STATE BOARD STAFF REPORT DECLARATORY RULING REQUEST

I. Request for Declaratory Ruling

Ann & Robert H. Lurie Children's Hospital of Chicago is requesting to change the net revenue by payor source for CY 2022.

II. Background Information

Ann & Robert H. Lurie Children's Hospital of Chicago is a 364-bed pediatric hospital located in Chicago, Illinois. The Hospital is a safety net provider. The table below documents the 2023 utilization for the pediatric hospital.

III. Proposed Change

The Hospital stated in CY 2022 the Hospital reported to the State Board patients with private insurance were included in the private insurance category instead of the source of the individual payments some of which were from private insurance and some from the patient. The Hospital added a total of \$21,848,498 to private payment and reduced private insurance by the same amount. See Table Two below.

IV. Applicable Statute and Rules

Section 1130.810 - Declaratory Rulings

HFSRB shall render determinations on various matters relating to permits and the applicability of the statute and regulations. Requests for determinations shall be made in writing. Pursuant to Section 5-150 of the Illinois Administrative Procedure Act, these determinations are declaratory rulings and are not subject to appeal. Matters subject to declaratory rulings by HFSRB include, but are not limited to:

- a) whether a proposed project requires a permit or exemption.
- b) corrections to the facility inventories utilized by HFSRB.
- c) recognition that a particular service was in existence prior to permit requirements.
- d) amount of fees required.
- e) project classification as substantive or non-substantive; and
- f) applicability of rules.

HFSRB NOTE: Declaratory ruling requests pertaining to an application for permit or exemption during the review period may be submitted only by the applicant and by HFSRB staff.

Re: Notice of Correction to IDPH Hospital Questionnaire for 2022

Dear Mr. Roate,

This letter acts as a request for correction to Ann & Robert H. Lurie Children's Hospital of Chicago ("Lurie Children's") Annual Hospital Questionnaire for 2022, which was submitted in April 2023. It has come to our attention that we incorrectly categorized certain net revenues by source for Fiscal Year 2022 on page 16 of the Questionnaire, Inpatient & Outpatient Net Revenue by Source for the Facility Fiscal Year. All dollars received from a patient with Private Insurance were included in the Private Insurance category, rather than using the source of the individual payments, some of which were from insurance, and some from the patients. This impacted the information in the Private Insurance and Private Payment categories, which resulted in over reporting Private Insurance and under reporting Private Payment. The total dollars did not change, only the allocation between Private Insurance and Private Payment has changed.

As such, Lurie Children's is requesting to restate its Inpatient & Outpatient Net Revenue by Source for the Facility Fiscal Year 2022. Below is a comparison of the data submitted by Lurie Children's and the requested corrections:
