The Huntley Fire Protection District fully supports Project # 10-090 and Centegra Health System's proposal to bring a new hospital in southern McHenry County. The need for a full-service hospital in this area is warranted. Huntley and the surrounding communities make up one of the fastest-growing areas not only in McHenry County, but in the entire state. These communities are currently underserved by healthcare facilities, leaving local residents and workers with significant travel times to existing area hospitals.

In 2010, the Huntley Fire Protection District responded to 2932 emergency medical calls for service. This number represents a 24 % increase over the previous year and the District has experienced an increase in EMS calls every year for the past 10 years. This trend is likely to continue well into the future. Currently, our travel time to the nearest hospital averages over 15 minutes. A full service hospital in our home community will greatly reduce travel time and improve patient outcome in advanced life support cases.

We urge the Illinois Health Facilities Services and Review Board to approve Centegra Hospital – Huntley, Project # 10-090.



I know Centegra Health System takes its responsibility to the community very seriously and continues to look for ways to improve the care it provides.


Centegra has long been committed to Huntley and the surrounding communities through outpatient services and other health services that have already been brought to the area.
