
Dear Ms. Avery:

I am writing to give my full support for a new hospital in Huntley. I've lived in Lake in the Hills for over 20 years and have watched our community grow from 6000 people in 1990 to over 29,000 people in 2010 or 486%. At the same time, our neighbors; Algonquin and Huntley have also grown significantly from a combined population of 14116 in 1990 to over 54,000 in 2010. The current combined population of the three communities is over 83,500 people with the majority living near; or west of Randall Road. Huntley is expected to double in size over the next 20 years and future growth of McHenry County is expected to occur along the Route 47 corridor and westward. The Huntley location also has easy access to major highways including; Randall Road, Algonquin Road, Route 47 and Interstate 90.

Centegra has been an outstanding partner with McHenry County for many years, with facilities in McHenry and Woodstock. They have provided jobs and easy access to needed healthcare and fitness centers throughout the area. In addition, they already own 110 acres for the proposed hospital, which includes a state-of-the art Immediate Care Center to provide local outpatient services.
