

On behalf of my constituents in District 1 who would be served by this proposed new hospital, I am writing in support of the 128 bed acute care hospital proposed by Mercy Health System for Crystal Lake, IL. The population of McHenry County continues to grow dramatically (44% from 1990 to 2000 and 18% from 2000 to 2010). The need for expanded health services in this region has been demonstrated by the State of Illinois. Mercy's plan to construct a new acute care hospital and medical office building accomplishes this need in several ways. First, Mercy's proposed hospital is centrally located to a large and expanding segment of the population that it will serve. 
