Closing Oak Forest a political farce

For the third time in less than a year, professional staff members at the Illinois Department of Public Health have recommended against closing Oak Forest Hospital.

But Cook County, which owns and operates the hospital, continues to seek the approval of the Illinois Health Facilities and Services Review Board to do exactly that.

In May, four of the five review board members in attendance voted to close the hospital, but an oddity in the state law requires that a majority of the nine-member board vote in favor of closing a hospital.

Gov. Pat Quinn had left three of the seats on the review board vacant.

So one "No" vote was enough to stop Cook County from implementing its plan.

Editorial writers at the downtown papers expressed outrage that one vote could keep the hospital open and there were calls to disband the review board.

Cook County Board President Toni Preckwinkle called out Quinn publicly for failing to fill the vacant seats on the board.

And Quinn responded by naming three new members.

So Cook County, knowing the board had been packed in its favor, again filed an official request to shut down Oak Forest Hospital, which it owns and operates.

The state review board has no staff of its own and relies on the professional staff of the state Department of Public Health to review requests to build new hospitals and close old ones.

The members of the review board are appointees, people who may, or may not, have some knowledge of health care and serve on a part-time basis.

In a past incarnation under Gov. Rod Blagojevich, the board itself was packed with political appointees and tainted by backroom deals and pay-to-play politics.

But even in those days, the staff recommendations seemed to be on the up-and-up. The board simply refused to follow them.

Now, so-called good government types want the board to ignore the staff recommendations.

They say let the politicians of Cook County do what they want because they have a history of ... do I really have to complete that sentence.

Well, let's take Oak Forest Hospital.

It was supposed to serve the needs of poor people in the Southland who didn't have private insurance.

And it did a pretty good job of that for decades despite the fact that Cook County politicians wasted millions by staffing it with do-nothing patronage employees.

The hospital, the only one serving the needs of the uninsured in the South Suburbs, didn't even have a real emergency room.

Ambulances weren't allowed to bring sick people there.

The ER rooms were state of the art circa 1950.

In fact, Cook County officials proudly cite those facts now during public hearings to justify closing the hospital and its emergency room.

No sense pointing out it was the politicians who allowed the place to deteriorate.

Oak Forest Hospital is a drain on Cook County's budget.

That's the truth.

And given the realities of the financial situation, it's hard to make a good argument that it should be kept open.

Except that the official lies, half-

truths, and exaggerations ought to make taxpayers wretched.

Even this process of officially closing the hospital is a sham.

Cook County, since the review board voted "No," has effectively closed the hospital down.

There are no surgeries taking place there.

All of the specialists have been transferred to Stroger.

Inpatients are no longer admitted.

Yet, there has been no official reprimand from the state. There have been no fines levied. No one in an official capacity has said, "This is wrong."

Cook County has agreed to replace the ER with a 24/7 immediate care center.

On the campus of the hospital there will be outpatient cardiology, endocrinology, neurology, podiatry, gastroenterology, optometry, orthopedics, psychiatry, rehabilitation, pain management and more.

That's what Cook County promises.

Staff members at the Department of Public Health don't believe them.

"Given the large number of safety net patients Oak Forest hospital provides services for, it does appear that the proposed discontinuation will have an adverse impact on the access to care in the service area," the staff concluded.

On Aug. 16, the state review board will vote again on the county's request to close Oak Forest Hospital.

Someone on the board ought to ask County officials why they effectively shut the hospital down after they were told, "No."

Or maybe this is all about politics and not about health care for the poor. If that's the case, the state review board should be disbanded.
