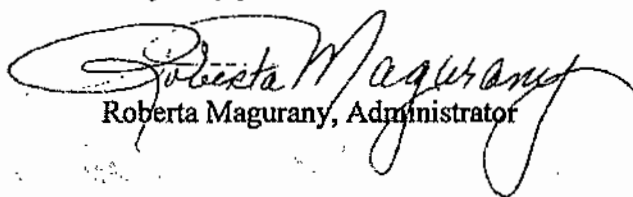
Dear Ms. Avery:

We have reviewed the State Agency Report ("SAR") for our Project 12-003 and appreciate the staff work on that analysis. Regrettably, we believe it appropriate to bring a recent change to your attention.

On March 30, 2012, Holy Family Village ("HFV") received a notice of a Type "A" violation. To my knowledge, this is the only such notice of violation ever received by Holy Family Villa in its 65-year history. We strongly disagree with the allegations and immediately requested a hearing to contest the matter. Although the issue will likely not be finally resolved for some time, we wish to be forthright with the Board in bringing it to your attention.

The SAR also discussed our 5-star rating. As a mechanical result of the allegations arising from the IDPH survey, HFV's star rating has been reduced. Our star rating will be reassessed once these administrative litigation matters are resolved and we are confident HFV deserves to remain a 5-star facility, but in the interest of transparency we wanted to make note of this issue with the Review Board.
