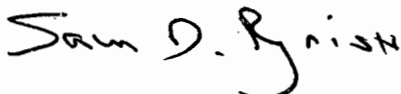
On 04/28/2016 the HFSRB provided notice to us that our project must be completed by 06/30/2016 and that our final realized costs report must be filed by 09/30/2016.
