SUPPLEMENTAL INFORMATION FOR #12-094 Fresenius Medical Care Prairie Meadows

In response to the Intent to Deny issued to project #12-094 at the March 26, 2013 meeting, Fresenius Medical Care is submitting this additional information and requests the Board to reconsider its decision based on the following information.

The most convincing information that is “new” to this project is the growth of ESRD in the 30-minute travel area around Libertyville, where the Prairie Meadows clinic will be located. **In just one year there are 29 additional patients dialyzing in the Libertyville area.** At this rate, the area clinics will be at 79% average utilization in one more year and yet it will be approximately 18 months before the Prairie Meadows facility is operational. It is appropriate planning to bring this application before you now in order to meet the future need as evidenced by current growth.

Since we were not able to give a presentation before the Board at the March meeting when the intent-to-deny was issued, we want to point out a few key supportive facts from the application as listed below.

- Libertyville is centrally located in Lake County and is a densely populated “hub” for area residents.
 - Condell Medical Center is located here making Libertyville a health care destination.
 - Dr. Trob’s patient practice is located in Libertyville and has more than tripled since 2009 from 95 to 379.
 - The town of Libertyville recently lost a dialysis clinic when DaVita Lake County was permitted to move approximately 7 miles away to Vernon Hills.
- Clinics within 30 minutes travel time are operating at an average 71.86% utilization as shown in chart above, however those clinics closest to Libertyville (within 20 minutes) are operating at an average 76.36% utilization.
- The population of HSA 8 (Lake, McHenry and Kane Counties) has grown 17% in the past decade compared to the overall State population growth of only 3%.
 - The elderly population in HSA 8 doubled with Lake County experiencing the highest growth in the elderly population of 155%.
 - The elderly are more likely to require dialysis services due to increased incidence of diabetes, hypertension and heart disease.
 - The Hispanic population in HSA 8 grew by 60%.
 - The Hispanic population is twice as likely as the general population to have diabetes and hypertension, the two main causes of kidney failure.

As mentioned previously, this facility will not be operating for approximately 18 months. The documented growth of ESRD patients combined with the ratio of stations to population within 30 minutes support the need for additional stations. As stated in the application, the ratio of stations to population is 1 station for every 6,255 residents. The overall State ratio is currently 1 station for every 3,187 residents demonstrating need per Board rules.

We respectfully ask the Board to reconsider their decision based on the need evidenced by the ESRD growth in this area of Lake County and approve this clinic to bring dialysis services back to the residents of Libertyville.
