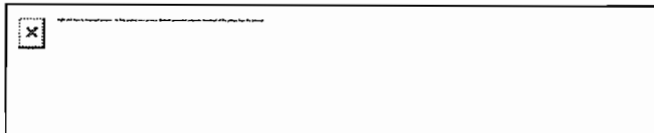

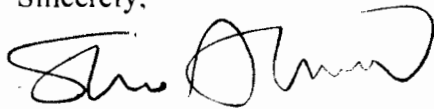

Dear Chairman Galassie:

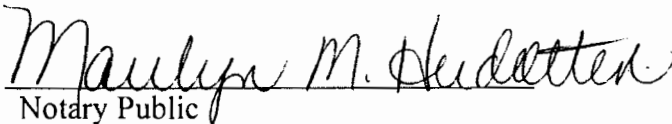
