To Whom It May Concern:

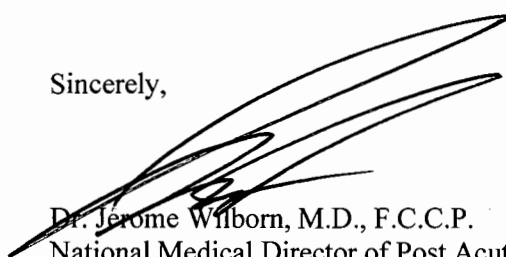

IPC anticipates that it can refer 135 patients annually to Transitional Care Center of Naperville within a 24-month period after the project is completed.

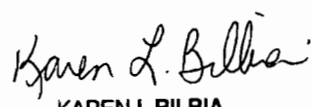
These projected patient referrals:
