My mother Phyllis A. Hatfield was one of the original founders of the Murray Parent's Association.

Earlier this year, I arranged for a visit for my sister in a local CILA home. It did not go well. The staff was not trained to watch for signs of failing health. Within 2 weeks, I asked for Jane's visit to end and return to her cottage.

I am writing to OPPOSE project #13-058!!

Many of the residents living well at Murray Center have behavioral, and health issues that staff at CILA homes and Workshops do not know how to deal with. Plus, all of the residents at CILA homes must attend a daily work-shop/activity. This does not work for all types of DD clients. The bus ride itself can be dangerous for them, plus the exposure to new environments and more air-borne diseases and viruses their system is not used to. They are not able to work little jobs, or perform daily living skill practices. Their speech, sight, and arms are not functioning in some cases.

CILA homes are not for all DD clients.

My parents fought for 35 years to keep Jane a Murray Developmental Center, and for good reasons. I will continue to fight for Jane's bests interests the rest of her life.

I am writing to OPPOSE Project #13-058 to close Murray Center. I do NOT support the closure of Murray Center. I wish for Murray Center to be kept open and operational.

My older brother, Phil Adcock, has lived at Murray Center since 1991. Phil is immobile, nonverbal, and completely dependent on those around him for assistance. I have read the letters from DHS, and I have listened to Kevin Casey speak, but I remain concerned that Phil would not receive an adequate level of care in a community home, let alone the care that he currently enjoys at Murray Center.

Even if Phil received an equivalent level of care in a community home, he would gain no real benefit in leaving Murray Center. He already participates in the community as much as possible, but his activities are necessarily limited, due to his immobility and fragile health.

I am also concerned that community homes already in use have had major problems, such as leaking roofs and weak floors. I fear that an immobile and nonverbal person like Phil would be in real danger from problems like these.

And I also fear that other residents of Murray Center who are mobile and verbal would be in danger in these homes. My understanding is that some of the residents of Murray Center were unable to live in community homes in the past, and I do not believe these past problems have been addressed, or even fully acknowledged.

I respectfully ask you to take all of these concerns into consideration, and I urge you to decline this project and keep Murray Center open and operational. Thank you for your time and consideration.

Dear Mr. Constantino:

I have been disgusted and appalled over the decision to close the Murray Center in our town. I am infuriated over how the bureaucrats from Springfield have chosen to use Southern Illinois as the "sacrificial lamb" by deciding to shut down a much valued and necessary facility in our area such as the Murray Center.

When the word first came out that Springfield was going to close Murray, this town rallied together in a way that I hadn't seen in my 10 years of living here. The fate of Murray was the only thing that anyone talked about around here for weeks. There were hundreds of green "Save Murray Center" signs everywhere you looked, and green ribbons on all the telephone poles. There was a huge rally of support at the center, which was attended by countless supporters on the front lawn of Murray, which was covered by the St. Louis news.

Of course, all of this support fell on deaf ears of Governor Quinn, who after the rally, unapologetically maintained his stance of closing down the center, with no regard to the lives that would be effected. We are going to lose hundreds of jobs in an area that is already economically depressed. When the jobs go, so will the disposable income, as well as reducing the odds of getting new business in this town. Who wants to start a business in a town where hundreds of people are unemployed? On that topic, what exactly is our town supposed to do with the vacant building that's left behind, since I can't imagine much demand for a building like Murray Center? Worst of all, what about the residents of Murray? Many of these mentally or physically handicapped residents know Murray as their only home. How can you look into the eyes of those patients, and tell them that the only life they know is coming to an end, with no clear cut outcome for them, because the State of Illinois no longer feels that these people are important enough to give them their much needed care? What do you tell the families of those patients? What do they do now?

Our community needs Murray Center. Our people need the jobs to live, and the residents and the family need the expert care from Murray Center in order to live, too.
