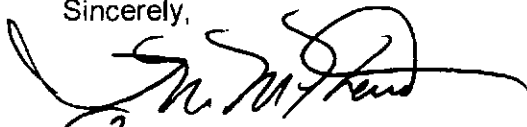
Dear Ms. Avery,

Our approved project was renewed on September 26, 2017 with a new February 27, 2018 completion date. The renewal was requested due to an unanticipated delay in compiling information for the final cost report (Section 1130.770). In compiling the final project information, we found the capitalized cost exceeded the CON approved amount by 1.34% necessitating a Project Alteration Request which was filed on November 14, 2017. On November 27, 2017, we provided additional information, as requested by your Staff.

Given the new project completion date is February 27, 2018, we respectfully request an expedited review of our recently filed Project Alteration Request. If an expedited review is granted, we believe our Project Alteration Request will be heard at the January 9, 2018 Review Board Meeting.
