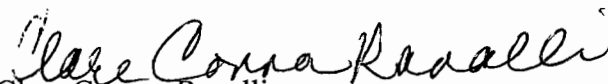

> Hi Karen:

>

> OK - I pulled the org charts showing pre change of membership interest and post, as well as a narrative description of the transaction and the license (all as submitted with the COE). The licensed entity - ROPH is not changing - it will still be Rush Oak Park Hospital, Inc., and it will have the same EIN and Medicare provider number.

>

> The bottom line is way back in the nineties Rush University Medical Center (then Rush Pres St. Luke's) became a member of Oak Park Hospital which had been solely owned by OSF. It ran and operated the hospital and the name was changed to Rush Oak Park Hospital, although OSF remained a member through a convoluted corporate structure. Eventually (in the last year) Rush determined that it wanted to buy the financial interest OSF retained in the hospital and OSF wanted to sell, so it bought out the membership interest. The issue that triggered the need for the change of ownership for CON purposes was the removal of Synergon (which was the entity that RUMC had an interest in and that owned Rush Oak Park). Nonetheless all of this is corporate re-structuring and does not change the licensed entity or the corporate member (Rush) that operated/managed the licensed entity (as Rush is now the sole member of Rush Oak Park).

>

> We can prepare a license app for a CHOW - we certainly have no objection to doing so. However, in the past as I mentioned if the licensed entity remained the same and the entity that essentially operated the licensed entity remained the same we have not had to do so - and therefore I wasn't sure if we needed to. I also thought it might not be necessary (although not really sure if it matters to IDPH one way or the other) since we do not have to file a new Form 855 with Medicare for a new number. We just have to send an information notice to Medicare.

> Hope this helps, and let me know your thoughts on this.
