Dear Mr. Constantino:

I am writing on behalf of Des Plaines Property, LLC and Asbury Court Nursing and Rehabilitation, LLC (collectively, the "Permit Holders") to request a renewal of Project permit 14-022, Asbury Court Nursing and Rehabilitation. On August 27, 2014, the Illinois Health Facilities and Services Review Board ("Board") approved the Permit Holders' application to establish a 71-bed general long-term care facility to be located at 1750 Elmhurst Road, Des Plaines, Illinois (the "Project"). Due to delays in licensure survey, the Permit Holders respectfully request a six month renewal of the Project permit and a new project completion date of January 31, 2019.

**1. Requested Project Completion Date**

The Permit Holders request the Board grant a six month renewal of the Project permit and establish January 31, 2019 as the new project completion date.

**2. Status of the Project**

Construction is complete and the facility is currently awaiting licensure survey. Based upon prior past experience, the Permit Holders anticipate licensure could take an additional three to six months.

The current project costs paid is \$7,656,049.68.

**3. Statement Regarding Completion of the Project**

As described more fully in the application, the Permit Holders are constructing a 71-bed general long-term care facility to be located in Des Plaines, Illinois. Construction is complete, and the facility is awaiting licensure survey. Accordingly, the Permit Holders respectfully request a six month extension.

**4. Confirmatory Evidence of Project Compliance**

Attached as Attachment 1 is the affidavit from Michael Zahtz confirming that the Permit Holders are complying with the scope and costs of the project approved by the Board pursuant to Project Permit #14-022

Based on the above information, which is provided to the Board in compliance with Section 1130.740 of the Illinois Administrative Code, the Permit Holders formally request a six month renewal of its permit for Project #14-022 and a new project completion date of January 31, 2018.

I, Michael Zahtz do hereby affirm and testify:



3. Additionally, I can attest that there currently exists sufficient financial resources to complete the project.


