This letter constitutes an Annual Progress Report on the above-referenced project, which was granted a CON permit at the October 7, 2014, meeting of the Illinois Health Facilities and Services Review Board. You may recall that this permit is to expand and modernize several departments at Copley Memorial Hospital.

The permit was approved with project costs of \$52,725,760. The sources of funds are \$16,225,760 in cash and securities and \$36,500,000 through Tax Exempt Revenue Bonds, as originally approved and as requested to revert back to in a letter which was acknowledged by your agency on March 20, 2019.

- 1. The current status of the project is as follows.
 - a. The project was obligated on May 11, 2015.
 - b. As of October 1, 2019, 100% of the project is finished.
 - c. The following components of the project have been completed.
 - All of the construction components of the project are complete.
 - Received final IDPH certification for full occupancy for the project on April 8, 2019.
 - d. There is no remaining work to be completed.
 - e. There are no changes in the scope of the project and its size from the permit as granted.

2. The costs incurred to date as of October 1, 2019 are \$40,894,204.

I am enclosing an itemized listing of the incurred project costs as of that date and a comparison of those costs to the approved permit amounts.

- 3. The method of financing the project and the source of funds are cash and securities and Tax Exempt Revenue Bonds, as referenced earlier in this Annual Project report, which was acknowledged by the Illinois Health Facilities and Services Review Board on March 20, 2019.
- 4. The project completion date is December 31, 2019.

We are currently undergoing an audit of the project costs and sources of funds and will submit the Report of Project Completion and Final Realized Costs, together with the audited financial report and AIA Form G702 in accordance with 77 IAC 1130.770(a)(5).
