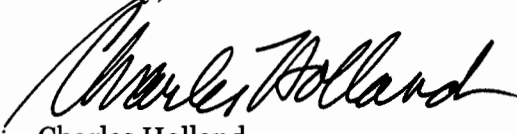
Dear Ms. Avery:

As you know, Chicago's South Side population and demographic characteristics indicate a medically underserved population, diminished health status, and a great need for preventative and ongoing care for those with many health related co-morbidities. In addition, the geographic area has identified environmental issues which have contributed to health problems in the area. Our proposed ACC/POB will improve access to health care services, which in turn will improve the health of the population on Chicago's South Side.

Although not directly related to health care delivery or our Permit Application, the proposed project's potential contribution to unwanted air pollution during construction has been raised. We have received a letter from the Environmental Law & Policy Center regarding this issue. Comments were also made at the September 15th Public Hearing. Please be assured we take this very seriously. We will be working closely with our construction manager, Berglund Construction, to mitigate any related short-term environmental concerns if our CON Permit Application is approved by the Review Board. I have attached a letter from Mr. Tom Sicinski from Berglund. Already a meeting has been set up on Friday, September 19, to address the environmental concerns.
