Resolution Opposing the Relocation of St. Elizabeth's Hospital Outside of Belleville

WHEREAS, the Board of Education ("Board") of Belleville Public School District No. 118 ("School District") considers it to be vital that quality medical care be available in Belleville for its students, employees, and their families; and

WHEREAS, the Board acknowledges that St. Elizabeth's Hospital has been a long-standing anchor to the downtown Belleville business community and long provided quality healthcare and services to the students, employees and families of the School District; and

WHEREAS, the Board has seen media reports that the Hospital Sisters Health System has submitted a Certificate of Need to the state to relocate St. Elizabeth's Hospital from its downtown Belleville location to another location which is outside Belleville and the boundaries of the School District.

NOW, THEREFORE, Be It Resolved by the Board of Education of Belleville Public School District No. 118, County of St. Clair, State of Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. The Board of Education of Belleville Public School District 118 hereby declares its opposition to the proposed relocation of St. Elizabeth's Hospital outside of Belleville, further finding that such relocation would be detrimental to the best interests of the School District, its students, employees and their families, as well as to Belleville and the surrounding region.

Section 3. The Superintendent of the School District is hereby directed to disseminate this Resolution as appropriate.

Section 4: This Resolution shall be in full force and effect immediately upon its passage.

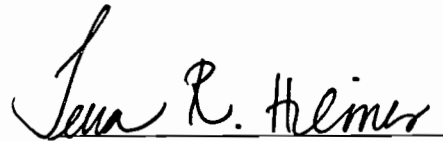

Dear Ms. Avery,

I am writing in opposition to St. Elizabeth's Hospital's planned move from Belleville to the O'Fallon area. The residents of Belleville depend on St. Elizabeth's convenient downtown Belleville location. I have worked for a large surgical group in downtown Belleville for 19 years and I observed this first hand. This downtown Belleville Surgical Group comprised of 9 surgeons, are on staff at both Belleville hospitals. Several patients, on a daily basis, requested their surgeries, testing, and admissions be scheduled at St. Elizabeth's Hospital solely due to location and transportation. Many patients insisted on scheduling procedures and admissions at St. Elizabeth's convenient location even if it meant waiting an extra few days due to openings in the schedule.

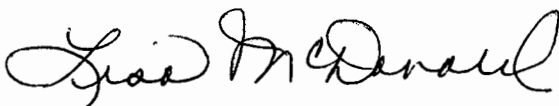
The physicians of Belleville, the citizens of Belleville, and the city of Belleville have been very supportive of St. Elizabeth's Hospital. There are numerous medical office facilities, filled with physicians, located on all corners surrounding St. Elizabeth's Hospitals current location. 311 West Lincoln Street, 340 West Lincoln Street, 301 West Lincoln Street, and 180 South 3rd Street in Belleville are all office complex buildings filled with physicians serving the downtown Belleville residents and St. Elizabeth's current location. What will happen to these thriving facilities if St. Elizabeth's Hospital abandoned the area? Belleville is very dependent on St. Elizabeth's Hospital centralized location. A move from this area would be deserting the population that has supported them for decades.

I hope you will consider the Belleville resident's access to care. The current location of St. Elizabeth's Hospital is necessary for the Belleville residents. Leaving this location will leave a community without healthcare and will be duplicating service in the new planned location. We don't need our Hospital and Physicians departing the downtown Belleville area leaving vacant building.

Also, St. Elizabeth's Hospital's current location serves many small communities that sit to the south of Belleville. Freeburg, Smithton, New Athens, St. Libory, Fayetteville etc.... These communities rely on St. Elizabeth's for their hospital and Emergency care. By closing St. Elizabeth's current location, you are adding an additional 20 minute commute to their trip which is already in the neighborhood of 30 minutes or more. When seconds count asking an Emergency patient to travel close to an hour is outrageous. Lives will be lost if you allow St. Elizabeth's to relocate to O'Fallon, IL.

Please let the Certificate of Need serve the purpose of preventing St. Elizabeth's Hospital from deserting their patient's needs to move to an area where the needs are already covered. Let's not duplicate services in one area and leave another area without healthcare. Let's encourage St. Elizabeth's to stay in downtown Belleville and serve the community that has supported them for more than a century. These residents have grown to depend on St. Elizabeth's Hospital current location and will be without healthcare if St. Elizabeth's abandoned the downtown Belleville area.

Dear Mr. Constantino,

I would like to ask to the Illinois Health Facilities & Services Board to deny St. Elizabeth's Hospital's application to move to O'Fallon, IL. Belleville would be devastated by this move, and it's clearly for no other reason but money. They haven't invested in their hospital for years, and then use that as an excuse to say they need a hospital outside our city, further from thousands who are poor and don't have transportation. They tell the public they want to be a "regional" hospital...but they already are one. Of course, their new "region" would exclude E. St. Louis, and other poorer communities west of Belleville. Those people already have little access to health care. Now they want to make it harder?

Memorial Hospital is expanding into O'Fallon too, so it's not like O'Fallon will be without facilities. But then Memorial isn't closing up shop and abandoning Belleville either. In fact they've grown and expanded their medical campus in Belleville and have a vibrant and viable facility. Another excuse St. Elizabeth's puts out is that the size of their campus is so "limited". That's nonsense! The City would gladly work with them to acquire as much surrounding property as they could possibly need.

Belleville is an older city, and many folks count on having health care close-by. Many can't drive and rely on either public transportation or relatives and friends. The move from Belleville would surely drag with it dozens of physician practices that rely on adjacent access to the hospital they attend. So it wouldn't just be one less hospital, it would mean dozens of medical practices and their doctors leaving Belleville too.

And all this is for what...To not have to care for indigent and Medicaid eligible patients? To remove themselves from a community that's transitioning from practically all-white to racially integrated? Their rationale and rhetoric is no less transparent than any participant in white-flight. Or is it simply the pursuit of money? If this is supposedly a religiously-affiliated charitable institution, then this move is wrong.

Instead of abandoning Belleville and leaving a huge hole in the heart of the city, St. Elizabeth needs to invest in the community that has supported them for nearly 140 years. Let them build the new St. Elizabeth's Hospital in Belleville, not O'Fallon, or Shiloh.

I am writing this letter in opposition of Project #14-043, St. Elizabeth's proposal to build a replacement hospital in O'Fallon, Illinois.

Through filing of the Certificate of Need, St. Elizabeth's has inadvertently displayed their lack of concern for the residents of Belleville. Building a replacement hospital in O'Fallon will make the closing of St. Elizabeth's hospital in Belleville inevitable, a facility that Maryann Reese, president and CEO at St. Elizabeth's, has referred to as "deteriorating." What does this say about the quality of care that is currently available to patients who choose St. Elizabeth's? What are their plans for the years leading up to the opening of the O'Fallon location, if the current state of the facility is less than adequate? Do St. Elizabeth's and the Hospital Sisters Health System (HSHS) have an explanation for the existing condition of the Belleville facility? And what are they telling their employees? Be hopeful for approval? If they do not gain approval, what are their plans?

St. Elizabeth's announcement to build in O'Fallon seems to have been made prematurely, much like their decision to defame their facility in Belleville. Residents in the Metro East can no longer trust that St. Elizabeth's and HSHS will stay to serve communities where a need has been established. St. Elizabeth's lack of commitment in maintaining the Belleville facility is disappointing and gives reason to question whether their intentions for relocating are truly based on what is best for area patients.

Additional opposition for this proposed project has come from the Greater Belleville Chamber of Commerce, the Belleville City Council, Belleville District 118 and Belleville District 201. These agencies have a genuine interest in doing what is right for Belleville. Their resistance to this proposal illustrates what many Belleville residents think a replacement hospital in O'Fallon will mean for their community: loss of jobs, a negative impact on commerce in the downtown area, and, most importantly, decreased access for the ill and underserved.

St. Elizabeth's should not be given approval to build a new hospital while allowing their facility in Belleville to be in a state of disrepair. They should be held responsible for the current condition of their hospital and renew their commitment to Belleville by renovating and expanding the facility that already exists.

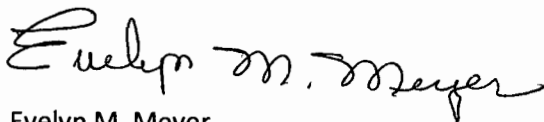
Dear Ms. Avery:

I am writing this letter in opposition to Project #14-043. I have several concerns regarding this project and am stating them below:

1. The people living in close proximity to the current St. Elizabeth's Hospital have used this facility for many years and many are not able to travel the distance they would have to travel in order to utilize a building at the site proposed by St. Elizabeth's. Many do not have cars and there is not an ideal metro system to take them to and from the current vicinity to the new one.
2. I have a friend who has a parent in a Geriatric facility five minutes away from St. Elizabeth's and feels comfortable when a crisis arises that she can count on help a mere five minutes away. If St. Elizabeth's close their downtown Belleville facility they would have to transport this patient to Memorial West or East which would involve 20 or more minutes. As you know, that is not a good thing for anyone in a critical care mode.
3. If this project was approved and the two new hospitals would be operating in the close proximity I have great concerns about certified professional employees being available to staff all centers adequately. I know there are reasons why the Illinois Health Facilities and Services Review Board has set up guidelines and cannot see how the approval of the second hospital could be approved in such close proximity.
4. Lastly I feel St. Elizabeth's is exhibiting a 'kind of blackmail' tactic when they say if the new project is not approved they will close the present facility and also that they will reapply until they are approved. This does not set well with me as I do not, in any way, condone this type of business.

I would like to voice my concerns about St. Elizabeth Hospital in Belleville, Illinois closing their excellent facility and moving to O'Fallon, Illinois.

I would like to address a couple of points:

1. There a great number of people who depend on the current location of St. Elizabeth. People from southwestern parts of Illinois drive some distance to use the hospital services. Moving further away from the current location would present a burden on this part of the population.
2. A number of people depend on public transportation, i.e. buses, Senior Service transportation options or just relatives who are willing to drive them. This population segment would be greatly disadvantaged by a move of the hospital to a more distant location.
3. The financially disadvantaged populace would have no recourse. They do not have extra money for gasoline, may not have a car at all, and would be further disengaged with health care participation.

I am writing to express my reasons for opposing the issuance of a certificate of need to St Elizabeth's Hospital.

I have been a resident of Belleville for forty-one years, and over the years my family and I have utilized both St Elizabeth's Hospital and Memorial Hospital in Belleville.

I feel St Elizabeth's had already made their decision to leave Belleville years ago when they chose to purchase the property on Green Mount Road in O'Fallon, foregoing any monetary improvements to the hospital located on South 3rd St in Belleville.

They own several properties in close proximity of the current hospital, and their claim of being land locked is unfounded. Also in 2006 St Elizabeth's Hospital opened a state of the art medical facility in Waterloo Illinois, and closed its doors after just four years; and currently sits vacant.

St. Louis University Hospital which houses separate buildings for different specialties and Barnes Hospital which is "land locked" has made commitments to the city of St Louis, and are ranked two of America's top hospitals.

Of note the current site of Lindenwood University Belleville Campus which is thriving, was at one time the old Belleville West High School. The University continues to invest in the city of Belleville.

Memorial Hospital was granted a certificate of need and is currently building its Memorial East site which is slated to admit its first patient in early 2016, and is only two miles away from the property located on Green Mount Road in O'Fallon, this in my opinion would be a duplication of services. Given the climate of healthcare it would be more than optimistic to think two hospitals two miles apart could survive financially.

I strongly oppose the issuance of a certificate of need to St Elizabeth's Hospital.

I am writing to express my concerns about the plans for St. Elizabeth's Belleville hospital to relocate from the City of Belleville to the proposed O'Fallon location. I believe this move will adversely impact meeting the health care needs of residents of Belleville and surrounding communities.

I grew up in East St. Louis. Having attended Catholic grade school and high school, it was only natural to consider volunteering at St. Elizabeth's during my high school years. I traveled by public bus from my high school to St. Elizabeth's. At that time we were called Mary's Helpers. I made this weekly trip after school in order to be part of the caring Catholic community that was part of St. Elizabeth's. I enjoyed working with the sisters as a volunteer and found the caring environment. However, I also attended the hearing on Thursday, October 2 and was upset at how the HSHS staff and St. Elizabeth's employees discussed the poor and unsafe conditions of their facility. I find it very disturbing that they would allow the condition of the hospital to decline as they outlined.

St. Elizabeth's states on their website under the "Community Benefit": "St. Elizabeth's Hospital has served this community since its founding in 1875 by the Hospital Sisters of St. Francis. From the very early days to the present, the hospital has a well-established tradition caring for those in need of health care and of partnering with the community to improve the overall health of the community". How can St. Elizabeth's continue to feel that they have a tradition of caring for the community, if they close their current site in the Belleville community?

Currently there is public transportation available to the Belleville site. By moving to O'Fallon, this will not be the case. Those that use the public transportation will have to seek care elsewhere. How does this reflect their mission of "well-established tradition caring for those in need of health care and of partnering with the community to improve the overall health of the community"?

Also with this relocation what impact will this have on the remaining hospital in Belleville and surrounding area? This will definitely impact Memorial Hospital, which remains committed to the Belleville Community needs.

For these reasons I am opposed to St. Elizabeth's proposal to relocate all their services to the O'Fallon location. Thank you for your attention to this matter.

We agree Belleville is no longer the epicenter it once was and this migration has traveled east to the O Fallon area. **Support letter #139** confirms this by stating, "I am a member of the St Clair County Board representing O Fallon". "O Fallon is the fastest growing city in the Metro East and this hospital will be needed due to the rapid growth of the city". One word that is frequently bantered about in conjunction with St Elizabeth's proposed move is "projection". With all of the rapid growth in this area we are concerned if this area is ready to safely assume another high priority institution, *at this time*.

"The O Fallon Fire and Rescue (O F F&R) provides protection to the citizens of O Fallon and the surrounding areas including the Village of Shiloh and the rural areas of the O Fallon, Shiloh Valley, Caseyville and St Clair Townships. This 44 square mile district is covered by 3 fire stations and is staffed with 45 dedicated and highly trained volunteers and 14 pieces of apparatus".

In 2012, **132,052** residents were under O FF&R protection. This figure equates to 1 volunteer Fire & Rescue person per 1 mile or 1 volunteer Fire & Rescue person per 2,934 residents. It is now 2 years later in 2014 with unknown added growth. Currently In the city of O Fallon and the village of Shiloh, while not including the 4 townships, are subdivisions, 12 schools, another currently being built, multiple senior assisted and nursing facilities, mega apartment complexes, business districts and now the Memorial Hospital East Campus currently under construction. To us these figures are troubling. How is it determined who receives the priority answer when more than 1 call is made at the same time in this 44 mile radius? At what point have we spread our volunteer firefighters too thin and placed the people they protect at risk? In no way should this be considered dissatisfaction in the work these individuals so selflessly serve. Rather they should be recognized and applauded for all that they do without asking for anything in return.

It is said in a medical emergency time is of the essence and it is often referred to as the Golden Hour. Green Mount Road, Frank Scott Parkway and Highway 159 are major connectors from Belleville to O Fallon. **Support letter #137** states "It is too my understanding there are many infrastructure improvements to be done in the O'Fallon area. Specifically Improvements to Interstate 64, Frank Scott Parkway, Green Mount Road and other traffic improvements. It seems to me **if** the improvements do come into fruition, the proposed location would have excellent ingress and egress access for emergency purposes".

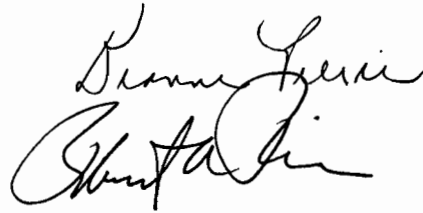
Much depends upon the word **if** in regards to infrastructure improvements. **"IF"** work is in the immediate plans for execution this is good. **"IF"** work has never been addressed, this is bad. These predominately 2 lane roads have served their purpose well but we cannot think of any improvements that have been gradually made in conjunction with or to support the area as it's grown. We cannot recall any published documentation released to the public where HSHS has addressed what impact their additional volume of traffic will have on the current infrastructure or what are the improvements needed to better serve the public and their patients safely and efficiently. We have read that proponents for the new hospital have said the travel to the new location will cause a minimal of disruption. For drivers who already frequent these roads they are known headaches. Daily, both Green Mount Road and Frank Scott Parkway are high volume with frequent snail pace movement to complete stops and this is with help of stoplights. Both have mega churches that on Sunday require the local police to direct traffic during morning hours. 7 days a week 159 from Belleville takes you through the business districts of both Swansea and Fairview Heights before reaching O Fallon. Traffic at the end of the work day through these areas only compounds the situation. What grants from the State or Federal Government have been applied for to help defray in the cost of upgrading? Are both Illinois for I 64 and St Clair County for Green Mount Road, Frank Scott Parkway, 159 and any other area already onboard and ready to begin with the needed work? What are their projected timelines when these improvements will be implemented and the projected date/dates their work is to come to fruition? **"If"** there are no answers to these questions, how can we possibly consider transporting patients in an emergency situation under these known existing conditions?

Support letter 10-1-2014 states "it is my understanding Metro Bus is planning to add the new hospital to its routes. This convenient location will also provide a direct line to its sister hospitals in Breese and Highland". Again, we are not aware of any published documentation released to the public where Metro Bus service has said they are onboard with and committed to HSHS's proposed hospital site or what are the locations of the new routes they will be providing.

At best when we speak of "it is my understanding there are many infrastructure improvements to be done in the O Fallon area" and "it is my understanding Metro Bus is planning to add the new hospital to its routes" this is all speculation at the present time.

Many proponents for the O Fallon relocation tell of how it will be more convenient for them to access a hospital at the proposed site due to the myriad of problems they experience when they travel to Belleville. For them it will be nice but for the majority of people now required to travel to this new location the problems will be amplified as they will have never been addressed and corrected.

Both St Elizabeth's and Memorial hospitals have well earned reputations and are held in the highest regard by those who support them. To us this has never been a personal issue of which institution, St Elizabeth's or Memorial hospital is better and more worthy than the other. I am a permanent deacon in the Catholic Church. As ordained members of the clergy, deacons participate in the three-fold office of word, sacrament, and charity. An essential element of diaconal ministry is the charity. This is particularly important in being an advocate for those on the margins of society.

The thing I love most about St. Elizabeth's is that it is an urban Catholic hospital providing healthcare to all because it is accessible to all. We are so blessed in Belleville to have a robust public transportation infrastructure. As a Downtown resident, I am amazed at how many people take the bus and metrolink to get to St. Elizabeth's. If you look at the Metro Transit – St. Louis map which I have attached, you can plainly see that Belleville is the public transportation hub in the metro-east. Public transportation makes healthcare truly accessible to all.

Like most Catholics I follow Pope Francis closely. The Holy Father wants the church to align more prominently with the world's poor and marginalized communities. In the first week of his papacy, he called for a church that is "poor, and for the poor." He has echoed this idea constantly since then.

Catholic health care facilities like St. Elizabeth are being called to help the pope lead the American church in this direction. After all, if measured in dollar terms, the American church's most substantial service to poor people already comes through its health care ministry, by far. I note this not as a point of pride, but simply to argue that Catholic health care is well positioned both to role model the pope's vision and to be a catalyst for the rest of the American church to explore how well (or not) we are serving poor, marginalized or disadvantaged communities.

It is not the time to be moving a Catholic hospital from a struggling community to an affluent community and to a location that has less access for the poor. This is an opportunity for St. Elizabeth's to assume a leadership role that is in alignment with its mission and the mission of the Church according to the Holy Father.

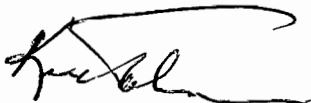
Ofallon will have the hospital being built by Memorial to help service the needs faster for that area so by not allowing St Elizabeth to move everything there will not harm that community.

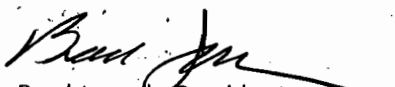

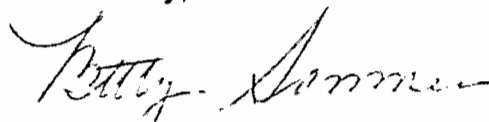
This letter is to share some thoughts regarding the possibility of losing the Belleville location of St. Elizabeth's hospital.

St. E's abandons its mission

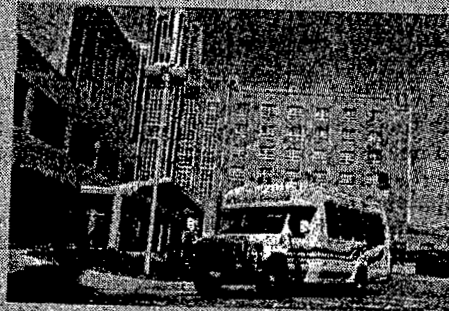
IT IS WITH great sadness that after 140 years in our community, we may be losing our hospital, St. Elizabeth's.
