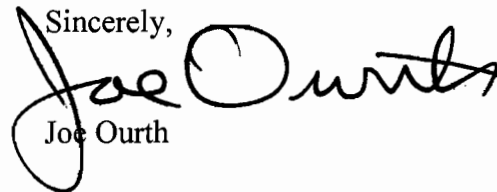
Dear Ms. Avery:

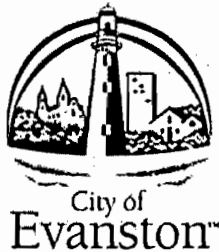

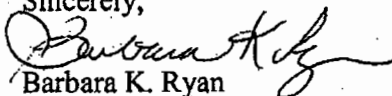

I am writing to express my support for the merger of NorthShore University HealthSystem and Advocate Health Care forming a new entity, Advocate NorthShore Health Partners. It is my understanding that the merger proposal has been submitted to the Illinois Health Facilities and Services Review Board for its review and approval.

As you know, I have had a long relationship with Advocate Health Care, especially Advocate Lutheran General Hospital (ALGH). My relationship began back in the 1980s when the wonderful health care professionals at ALGH helped saved my son, who was hospitalized there for over two months, from a life-threatening illness. That began an involvement on my part with one of our State's premier health care facilities. I served for many years on both the ALGH Development Council and the ALGH Governing Council, and I am presently on the Governing Council, having been Chair of the Council during the prior three years.

In addition to my service with ALGH, however, I have some fairly extensive experience in the health care area because of my position as Senior Vice President of the Illinois Hospital Association (IHA) for seven years. During my tenure at IHA, I witnessed tremendous change and consolidation in the health care landscape throughout the Chicago area and around our state. I saw both Advocate and NorthShore grow, growth which allowed each organization to provide higher levels of quality health care to patients.

With all the changes at the federal level, health care systems around the country are dealing with continued new requirements in providing health care services. Providers, individually and as systems, are being asked to do more with less. They must provide quality outcomes for the patients they serve without increasing costs.
