We believe that by transitioning endoscopies from a hospital setting to an outpatient setting, we are fulfilling our commitment to high-quality, lower-cost care.

As part of our mission, we provide the same care to all patients, regardless of their insurance status. I am told that many of the outpatient surgery centers in the Northwest Chicago region do not accept Medicaid patients or accept a very limited number, hindering access to care for these patients.
