I would like to take this opportunity to share how essential Herrin Hospital is to the greater Southern Illinois Community. Herrin hospital has been a provider of quality care in the region for over a century. I have always appreciated the organization's mission to provide healthcare to all patients, regardless of ability to pay as they serve an area with a high rate of poverty. Herrin Hospital consistently provides a tremendous amount of charity care through the Health Assistance Program and bad debt right-offs. I have come to find that Herrin Hospital's charity care totaled more than \$14 million in 2014 alone.

The hospital's physician recruitment efforts have brought over a half-dozen surgical specialists to the facility in recent years. This effort has caused outmigration for inpatient and outpatient surgeries to decrease. Continued recruitment efforts aim to bring in an additional three surgical specialists over the next 12 to 18 months. These specialists are crucial for the low income and vulnerable families in the region, due in part to the region's designations as a Health Professional Shortage Area and Medically Underserved Area.

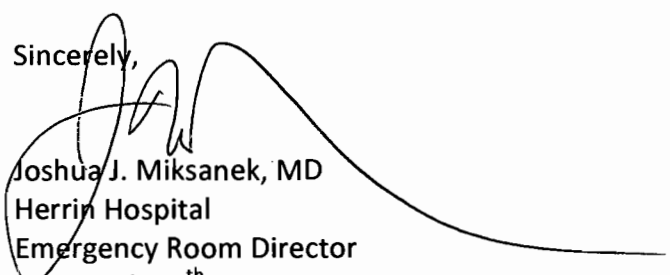
Dear Ms. Avery,

Please accept my letter of support for the proposed modernization and expansion of surgical services at Herrin Hospital. The project proposes to not only replace and expand antiquated operation room space, but also update and expand several ancillary areas to surgical services, including but not limited to endoscopy and minor procedure rooms, surgical prep and post-anesthesia recovery.

This request comes on the heels of dramatic increases in surgical cases and surgical hours over the last four years in particular. With the successful recruitment of additional surgical specialists to meet the regional health needs of our community, OR space is at a premium. At present, the existing operating rooms are sized extremely small by current clinical standards. With the proliferation of high-tech equipment and larger beds that are used today, the lack of space is a significant drawback.

This proposed modernization and expansion will not only reduce outmigration to nearby states for advanced care, but will also continue to meet the health needs of the regional community, which includes some of the most vulnerable patient populations in Illinois. Marshall Browning Hospital has a good working relationship with Herrin Hospital and many of the physicians on its staff. Patients having their surgery closer to home can more easily be referred back to the local community for follow-up care. As a safety net health system, Southern Illinois Healthcare provides a significant level of care to low-income and uninsured patients, with a large portion of that care being provided at Herrin Hospital.

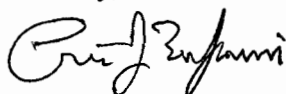
