SAMC has been a long-term member of RHC, and the hospital system carries a very high profile due to its support of many local Rockford area not-for-profit and charitable organizations.

The Health Council believes this project provides a substantial improvement in the quality of care SAMC will bring to its patients and the Rockford regional as a whole, for a number of reasons:

- Referring physicians and hospital clinical staff prefer their patients to reside in private rooms, not only for privacy reasons, but also for the ability to perform medical services in the room rather than in other, more expensive inpatient locations within the hospital;
- In that same vein, where physicians prefer private rooms for their patients, physician and other clinician recruitment opportunities will be enhanced. Accordingly, given Rockford's difficulty in attracting top-level practitioners, this project will help alleviate some of this problem.
- The opportunity for health care services of a higher level for patients is realized due to OSF's designation as a Level I trauma center;
