This report summarizes the development and final costs of the above-mentioned project which is for the addition of 5 stations to a 19-station ESRD facility located at 17225 S. Paxton, South Holland. The project was obligated with the installation of the five stations on March 20, 2016. There have been no changes to the scope and size of this project. The stations were operational as of May 25, 2016. The Permit amount is \$173,625. Final realized costs were \$101,007.

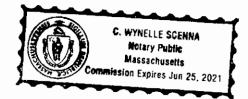
