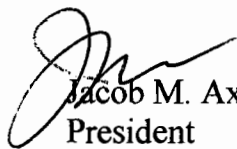

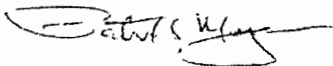
The purpose of this correspondence is to express support for Project #15-038 the reconfiguration of the existing Rockford Memorial Hospital Rockton Avenue facility and Project #15-039 the establishment of a second hospital campus on Riverside Boulevard.

Rockford Memorial is the Level III NICU for the Northwest Illinois Perinatal Network serving 15 hospitals. It is the only Perinatal Center from the West Chicago area to the Mississippi River. In addition, the hospital operates a 7 bed pediatric intensive care unit. Both services are of critical importance to the region.

Ann & Robert H. Lurie Children's Hospital of Chicago (formerly Children's Memorial Hospital) has maintained a long standing transfer agreement with Rockford Memorial Hospital to support the needs of patients from the Rockford community who require specialized services that are not otherwise available in the region. This past fiscal year there were 64 children transferred to Lurie Children's from Rockford Memorial many of whom were critically ill newborns. In addition, this past August we entered into an agreement to provide neurocritical care telemedicine coverage. This service provides patients in the Rockford Memorial emergency room, pediatric unit and PICU timely access to our highly trained team of Neurocritical Care physicians for the diagnosis and treatment for fragile patients.

Given the important services provided to the families in the Rockford area by Mercy Rockford Health System we support the projects referenced above.

This letter is submitted as an amendment to the letter dated August 21, 2015 in reference to the above stated Project Numbers proposed by MercyRockford Health System.

In the letter dated August 21, it was stated that Rochelle Community Hospital is supportive of the relocation of pediatric (including pediatric intensive care), neonatal, high risk obstetrical and women's services to the new campus proposed by MercyRockford. We continue to support this initiative.

However, it is now our understanding of the potential relocation of additional services above and beyond what is mentioned in the previous paragraph. We feel this would be a duplication of services already provided in this area. We currently have a relationship with another tertiary care provider for emergent and higher levels of care than we provide in Rochelle, and do not see added benefit for our patient population.
