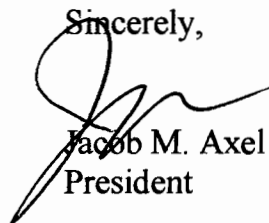

Dear Ms. Avery:

This letter is submitted in support of MercyRockford Health System's three applications.

I am a member of the Winnebago County Board and I have served for two terms as a Board member of Rock Valley College, including as the Board chair for two years.

I am strongly supportive of MercyRockford's applications that have been filed with your agency. The necessary development of the Rockton Avenue campus and the Riverside campus will strengthen access to care for many constituents. In a time of significant changes in the provision of health care services as a result of the implementation of the Affordable Care Act, I am concerned about insuring that prospective health care facility planning will prevent voids in services.

I am delighted that this plan proposes the introduction of modern facilities designed to accommodate state of the art technologies. I know that keeping pace with medical technological advances is essential to stop out migration for healthcare services. Rockford Memorial's neonatal and pediatric intensive care units are essential – not only to Rockford – but to all of northwestern Illinois.

I have studied the facility plan for MercyRockford's intention to provide two campuses and one hospital. The development of the Rockford Memorial's property on I-90 and Riverside Boulevard will have a significant impact on the economy of the Rock River Region. It will be the largest capital project in Winnebago County's history.

The facility will promote regionalism for job growth and creation in a manner that no other location can in and around the area.

The growing health care industry will help diversify the job base in the community to mesh with the expansion of the aerospace and manufacturing industries promoting efficiency, specialization, and education through research and development and lead to other industries that seek to complement or join such networks.

The creation of a Women's and Children Hospital at I-90 will make Rockford a medical destination. The new services that will be provided there will insure access to care for those who have often migrated outside the community for care.

Also, the University of Illinois College of Medicine in Rockford will supplement the state of the art medical technologies by developing pertinent residency programs that will supply additional physicians who could focus on medical specialties that aren't currently offered in the area.

At a time in which many organizations and businesses are choosing to exit Illinois or postpone investments in our State, I am heartened that MercyRockford has chosen to "put their money where their mouth is" and invest in Rockford and Illinois.
