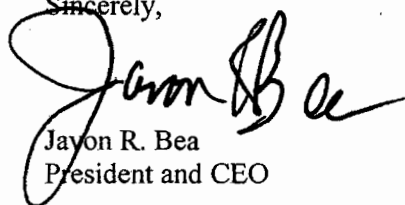

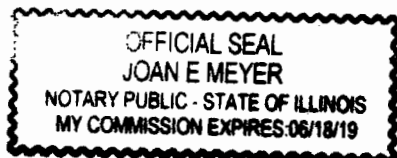

It is my understanding from Jack Axel that you have requested additional documentation related to Rockford Memorial Hospital's ownership of the "Riverside Property", as set forth in the legal description provided in our CON applications. The Riverside Property, in total, consists of about 263 acres, which includes 9 separate taxable parcels. RMH owns all but one small parcel (1.5 acre), which is owned by Rockford Health System and not related to the RMH property needed for the project.
