Ronald McDonald House Charities of Madison and Rockford Health System have a long partnership in our shared mission of providing for the health, wellness and wellbeing of children in need and their families, regardless of their ability to pay. I am writing to express strong support for the MercyRockford plans to build a state-of-the-art Women's and Children's hospital, to enhance clinical programs and increase regional access via its location on the interstate highway. We support these plans because they will provide updated facilities for the existing regionally designated perinatal and pediatric programs offered by MercyRockford. It will also enable MercyRockford to recruit additional pediatric specialties and grow programs to serve patients close to home.

We recognize the two-state geographic footprint of the new MercyRockford partnership and know that the new Women's and Children's Hospital will serve not only the 11-county region in northern Illinois but also a number counties in southern Wisconsin. For that reason we are engaged with MercyRockford to begin **exploration of plans to build a Ronald McDonald House on the E. Riverside Blvd. campus**. A Ronald McDonald House would provide a place for families from throughout the region to stay, at no cost, when their babies are in the Neonatal Intensive Care Unit or their children are hospitalized. If plans for the development of the Riverside Campus are approved, MercyRockford Health System has committed to helping to raise the funds to build a Ronald McDonald House on the campus.

In 2003, we began our partnership with Rockford Memorial Hospital to operate the Ronald McDonald Care Mobile, a 40-foot-long pediatric clinic on wheels that delivers free medical and

dental care to children in Winnebago, Boone, Lee, Ogle and Stephenson Counties. The vehicle houses two patient examination rooms, a laboratory, a reception area and a medical records area. A team of medical professionals, including a nurse practitioner, a dentist and a dental assistant, travel on the Care Mobile. Staff members on the Care Mobile also help enroll children in the State of Illinois All Kids Medicaid Program.

Ronald McDonald House Charities, Global donated the Care Mobile vehicle to Rockford Memorial. The hospital operates the program and helps provide charitable funding. In fact, the operations of the Care Mobile are completely funded by charitable donations, including annual grants from Ronald McDonald House Charities of Madison, the Rockford Memorial Hospital Auxiliary and the Rockford Memorial Development Foundation. In its 12 years of operation, the Care Mobile has provided more **10,000 free medical and dental visits**, totalling **more than \$1.8 million in free medical and dental care** for kids. Clearly, Rockford Health System – now part of MercyRockford – has a deep commitment to serving children in need in Rockford and the region.

For its commitment to providing excellent healthcare to children and support for families, we enthusiastically support the MercyRockford plans and urge their approval.

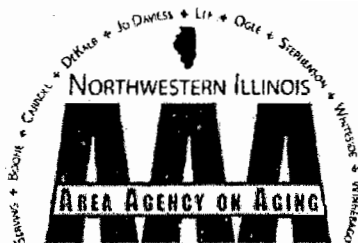

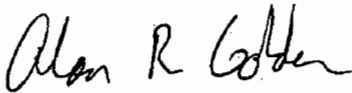

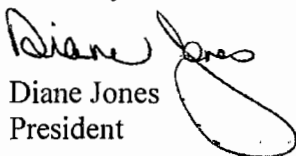

Dear Ms. Avery:

I am a pediatrician with Rockford Health System, a Faculty Member of the University of Illinois College of Medicine at Rockford, and the Medical Director of the Medical Evaluation Response Initiative Team (**MERIT**) program. MERIT is a collaborative program, organized under the auspices of University of Illinois College of Medicine - Rockford (UICOM-R) and housed at the Rockford Health System N. Rockton Ave. campus, which provides medical exams for children who are victims of abuse.

This letter is submitted in support of MercyRockford Health System's three applications and its leading role as a provider of medical services to children in the region, including children who are abused and at risk.

Rockford Health System provides support that enables me to serve as medical director for the MERIT program and also provides a grant through the Rockford Memorial Development Foundation to help fund the operation of the program. Medical exams of abused children are primarily provided for cases originating in Winnebago and Boone counties. MERIT works closely with the Carrie Lynn Center, local DCFS, Law enforcement, and the State's Attorney to process cases as the facts are determined. The program also has a large educational component. MERIT personnel reach out to judges, hospital exam room personnel, physicians and other providers to help inform them about identifying and assessing these types of cases. In addition, medical students, family practice residents and advanced nurse practitioner students rotate through the program to learn about these types of cases.

MERIT provides expert medical evaluations and consultations children aged 17 and under for sexual abuse cases, physical abuse cases—including, but not limited to, head injuries, bone fractures, internal injuries, burns—and severe neglect cases that are under investigation for child maltreatment. Referrals are accepted from appropriate

sources-law Enforcement (LE), State's Attorney, DCFS, primary care providers, ER providers and CACs.

I am strongly supportive of initiatives, like the MercyRockford projects, that will help insure access to care for the residents of our community, particularly children. I am grateful that MercyRockford's plans insure the continued vitality of the N. Rockton Avenue campus where I practice and the continued provision of compassionate, professional medical care for children who are victims of physical abuse, sexual abuse or neglect. I urge you to approve the MercyRockford applications.

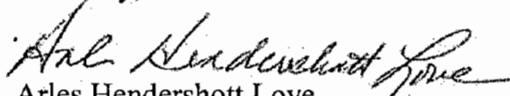

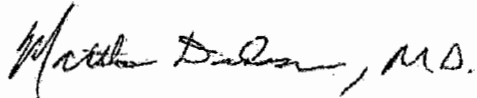

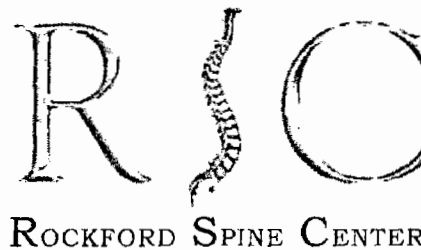

In our facility we have seven physicians, a nurse practitioner and three physician assistants who are all clinicians who provide care in regards to spine evaluation, treatment and pain management procedures, as well as spinal surgical procedures at the hospitals. Amongst all our care providers we see approximately 4000 patient visits per year and perform close to 1000 surgeries per year. Our referral base is from Wisconsin, Iowa, and Northern Illinois including Chicago and Madison areas and as far south as Peoria.

The physicians of Rockford Spine Center are recognized nationally and internationally as experts in spinal reconstructive surgery and as a group we have published multiple research and scientific articles and provide university level services to the Northern Illinois community.

I am strongly supportive of MercyRockford's applications that have been filed with your agency. I think it would be critical to develop a modern treatment facility here in Rockford that is close to the interstate to allow greater access for the large volume of regional referrals that we currently receive. The most complex surgical procedures are preferentially performed currently at MercyRockford Health Systems; however, the campus is aging, in great need of updating, and to a certain extent the facilities are beyond updating and need replacement. To the extent that a new location would be a great benefit for regional referrals as well as building of the new facility to allow updated operating theaters and other supportive services to continue supporting the regional several state area that we currently serve.

Further, I believe the MercyRockford Health Systems sustaining a clinic on the west side of Rockford will continue to serve the residents of the west side of Rockford; however, a new facility at the proposed location of Riverside and Interstate 90 would not only benefit providing care to

the eastern side of Rockford, but also significantly improves the accessibility for our volume of regional referrals and as such would have a significantly positive financial impact on Rockford as a whole as well as the Northern Illinois region in regards to construction, support services, hospital personnel, and development of those same services. Additionally, improving our regional services will allow us to not only continue serving patients who are in need of these advanced services here in the Rockford area and preventing an outflow to areas such as Madison, Wisconsin, but also increase the influx of patients from out-of-state area as well as the Northern Illinois regional area to the Rockford area.

I would like to point out that moving services to the proposed location is a relatively short distance and should not affect access for anybody here in the Rockford area to any appreciable degree but has the added benefit of improving regional access. At a time when economic conditions in Illinois are becoming critical with businesses leaving the state, I think the proposal for Mercy/Rockford Health Systems construction of a new hospital facility is a step in the right direction at keeping jobs in Northern Illinois as well as business and promoting further growth in the health industry and as a whole is a definite positive for Illinois as a state and definitely for Rockford in the region.

Our journey with RMH started in August 2nd, 2011 when our twins were born way too early at 23 weeks and 5 days gestation. Our daughter Faith passed away after 3 days of fighting, and our son Evan spent the next 7 months in the NICU. There were a lot of tough and good moments with Evan but he is now a happy healthy 4 year old.

In those 7 months we were there every day for several hours a day so we got to know all the staff and other families very well. The care we received from them was outstanding. Evan, and by extension us, became part of their family and they became part of ours.

Based on the experience we had in the NICU along with knowing the experiences other families in the NICU went through, we support the new facilities plan for two main reasons

- While the care we received was outstanding, the facilities were not set up in a way to best allow the development of the smallest of baby's brains. The environment was just too bright and noisy for those young brains development, despite the staff's best efforts to keep it quiet and dark. Evan's biggest issue today is sensory processing and studies have shown that an overly stimulating environment during critical brain development can lead to sensory processing difficulties. A modern facility designed around those critical issues can help give the next generation of NICU babies a healthier development environment.
- The current location is not accessible for a lot of families from out of town. There is no good way to get to the current RMH campus. We were lucky enough to live in town and could be there every day, but several families that we became friends with did not have that luxury and could only come to see their children on the weekends because of the travel time and work schedules. I can't imagine not being able to see my child every day. Moving to a location close to the expressway will allow families to be able to see their children more often.
