I am writing this letter with concerns to the proposed new skilled nursing center in McHenry. I have been an employee of Crystal Pines Nursing and Rehabilitation for 6 years. I started out as a C.N.A providing clinical care to the skilled guests at this facility. I am currently a member of the activities team and assist in the recruiting efforts for the facility. As a clinical staff recruiter, I can attest to how difficult it is to hire clinical staff in an already saturated market.

I have been a community member for 25 years and have witnessed many changes in the area. Some of these changes have been positive but this proposal has me concerned. Our facility prides itself in providing exceptional care for our community members, with an emphasis on hiring the best of the best to care for our guests. Being a rural area it is already challenging finding tenured long-term care staff that can provide this exceptional care. Concerning this proposal my fear is that this pool of expertise will be strained having a negative impact on the current community members entrusted to our care. It is rare that any long-term care facility in the area is at full capacity, and this proposal will create a financial burden on the current facilities that have been providing this exceptional care for many years. Please consider these concerns when the board reviews this proposal. It would be heartbreaking to see the negative affect on the guests, community, and staff.
