We are writing to protest the closing and demolition of the Palos Health & Fitness Center (PHFC) in Orland Park, Illinois to accommodate the expansion of the hospital center next door. The PHFC was built and promoted as a local fitness and therapy center. Over the years, people have used and still use this facility for many reasons, from general fitness to targeted therapeutic care. This facility and staff have become irreplaceable!

Having both cold and warm water therapy pools, PHFC offers specialty services and classes for neuromuscular disorders, orthopedic services, and difficult health deficiencies. The Center offers classes on multiple topics for both members and non-members to promote a healthy lifestyle. With an aging local population, services offered by PHFC will only be in greater demand.

Demolishing this building will result in a significant loss to our community, and beyond. Why can't the building and garage expansion move to the west side of the current building where there is plenty of acreage for expansion?

The letter published by the hospital said this construction needs to be done to better-serve the community-at-large. If trying to better the community, do not demolish this 'gem' of a facility! With the new University of Chicago Medical Center site currently under construction only 2 miles away, this area will be over-built with specialized medical centers.

Please work to find a way to save PHFC – I don't know of anyone who is in favor of its demolition!


Reference: Board Matters-Closing of Palos Hospital Health & Fitness Club
