I am a life-long resident of the Chicago Southland, and I have depended on St. James Hospital to get me through two life-threatening situations.

In the early 1980's, my husband and I were living in Richton Park: about 10 miles west of St. James Hospital in Chicago Heights. I had been experiencing abdominal pain that became so bad that my husband drove me to the emergency room at St. James late on a Saturday night. It turned out that I had a ruptured appendix. The staff members at St. James who treated me were efficient, effective and supportive. I had a long hospital stay, and I can honestly say that the quality of the care I received was excellent. St. James saved my life, and I was grateful.


Ten years later, after moving to Orland Park, I had occasion to be admitted to St. James again. This time I had a life-threatening asthma attack at my doctor's office in Chicago Heights. I dreaded the thought of being admitted to the hospital because the wait can be long, and it gets harder breathe. Once again, the St. James medical staff was there for me. They responded with lightning speed, and the outcome was terrific. St. James saved my life a second time.

I am aware of the controversy caused by the proposed consolidation. That is why I feel compelled to share my story. On the two occasions I had to travel to Chicago Heights, I thought it was worth it. The outcomes speak for themselves. I am grateful that St. James was and continues to be there for me.

I tell you this because I am concerned that if the Certificate of Need is denied, the quality of health care I rely on will be greatly diminished. I don't think anyone believes that a hospital can thrive when forced to duplicate very costly services like surgical units and emergency departments.

I implore you to approve the Certificate of Need so that St. James can redirect the resources currently being used for duplicative services toward primary care and community services designed to keep all of us healthy and out of the hospital.

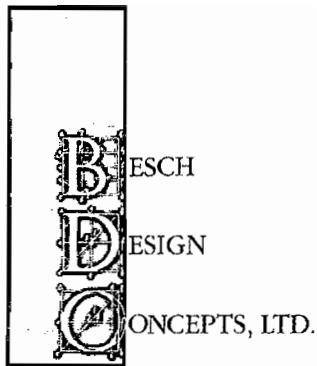
Dear Ms. Avery:


