Appended as **Exhibit I** is a listing of area facilities, utilization, and travel times for the 45-minute travel time. IT should be known that there are three distinct service areas required by the Certificate of Need process, the Planning Area (7-C DuPage County), a 30-minute travel time (included in the CON as originally filed), and a 45-minute travel time. The property is located at the North end of DuPage County. Moreover, the Village of Bartlett overlaps Planning Areas 7-C and 7-A. Respectively these service areas have calculated needs for 138 and 462 additional beds by 2018. Factoring out the excess beds of Kane County Planning Area, there is still a need in this area for 221 additional nursing beds in the tri county (Planning Area) area.

Regarding the applicant for the proposed project, it should be known that Bartlett Investments I, LLC is the sole shareholder of both Alden Bartlett, LLC (owner) and Alden Estates of Bartlett, Inc. (operator). As such, Bartlett Investments I, LLC is a co-Applicant to the ownership and operating entities. Additionally, The Alden Group, Ltd is the sole shareholder of Bartlett Investments I, LLC and sole financial contributor. As such it is also a co-Applicant.
