Dear Ms. Avery:

I am writing to encourage the Illinois Health Facilities and Services Review Board to support the University of Chicago Medicine's plan to increase access to care for patients on Chicago's South Side.

As the CEO of Roseland Community Hospital, I know our community has unique health care needs yet fewer resources to meet those needs. African Americans have a higher incidence of certain types of cancer, and higher mortality rates when cancer strikes, often because of a lack of access to quality care.

Additionally, our patients live in an area where there is limited access to Level 1 adult trauma care, yet approximately one-half of trauma cases originate in this area.

UChicago Medicine's plan would strengthen community hospitals by strengthening our entire network of care. The plan would increase access to the very care patients most need with a state of the art emergency room that will improve patient safety; a dedicated and expanded cancer hospital to give our community a world-class patient experience; and a Level 1 adult trauma center to care for trauma victims.

I strongly encourage you to approve UChicago Medicine's plan, and improve health care for all on Chicago's South Side.
