

This letter is in support of US Healthvest's proposed behavioral hospital in Northbrook.

There is an unmet need in the surrounding area for specialized psychiatric services that is resulting in patients being deferred or denied treatment. Approval of US HealthVest's application will increase access to these important services.

Here at Youth Services, we are seeing more and more children struggling with severe mental health diagnosis'. These problems are presenting at younger ages, hindering the child's ability to function successfully at home, in school, and in the community. Oftentimes, these struggles warrant a psychiatric evaluation and/or hospitalization in order to stabilize the child. However, YSGN's counselors are having much difficulty finding programs that are both specialized and available immediately to the family.

That is why we were so relieved after being notified of the Chicago Behavioral Hospital in Des Plaines. Approximately two months ago, one of our clients voiced that she was suicidal. We immediately referred her the facility in Des Plaines. We were then notified by the intake worker within an hour that a psychiatric evaluation was completed and the child was hospitalized as a result. During the child's hospitalization, hospital counselors were in constant communication with our counselors. The child was successfully discharged two weeks later, and the hospital continued to follow up regarding progress. I cannot stress enough how thoroughly impressed we were with the level of care and expertise that this child received. I can say with 100% confidence that a facility in Northbrook would answer the call for so many area children and families sharing similar struggles.

I urge you to support the approval of US Health Vest's behavioral hospital and thank you for your assistance in providing access to care.
