As the physicians state in their letter in Appendix 1, in the first quarter of 2016, they have referred 175 of their ESRD patients, who reside within a five-mile radius of the proposed facility, to dialysis centers in the area. After accounting for those patients who either will no longer need hemodialysis, due to a change in their condition, or choose to continue dialysis at the same facility, the physicians conservatively estimate that they will refer at least 10 of those patients to Applicants' facility, within the first two years of its operation. The physicians estimate referring the following number of patients from area facilities.

In addition, the physicians have identified 637 patients with diagnoses of CKD 3, CKD 4, or CKD 5, whom they are currently treating and who will require dialysis services in the future. The physicians estimate that they will refer approximately 61 of them, who live within five miles of the proposed facility, to Applicants' facility, within 24 months of project completion (approximately 30 patients annually).

On behalf of Southwest Nephrology Associates, S.C., comprised of Drs. Obasi, Guglielmi, Thomas, Ahuja, McLaughlin, Patel, Selk, Desai, Raju and Onyenwenyi, and Advanced Practice Nurses Christine Sutich, APN/CNS, CNN, Lilla Wojciechowski, APN/ANP-BC and Latrina Dunn-Lenoir, APN, I write to reiterate our support of the certificate of need application for the proposed U.S. Renal Care West Chicago, LLC Dialysis facility and to clarify the estimated number of our patients we plan to refer to the facility.

Currently, we treat patients who receive their dialysis at the following facilities: DaVita Beverly, DaVita Mt. Greenwood, DaVita West Lawn, DSI Scottsdale, Fresenius Medical Care – Alsip, Fresenius Medical Care – Crestwood, Fresenius Medical Care – Merrionette Park, Fresenius Medical Care – Mokena, Fresenius Medical Care – Oak Forest, Fresenius Medical Care – South Side, or who receive their dialysis through home modalities. Based on our records, in the five-mile radius of the proposed facility, we treated 190 ESRD patients in 2013, 174 ESRD patients in 2014, 171 ESRD patients in 2015, and 175 ESRD patients through the first quarter of 2016, as reported to the Renal Network. *Table A* lists total patients whom we referred to area dialysis facilities, which is organized by year, patient zip code, and dialysis facility. Within 2 years after U.S. Renal Care Hickory Hills opens, we conservatively estimate that we will refer to that facility at least 10 of our patients who are then receiving dialysis services at another facility in the area.

With respect to new patients, in 2015, we referred 52 patients who live in the five-mile radius of the proposed facility, for hemodialysis to area facilities. *Table B* lists total new ESRD patients we referred to area dialysis facilities, by facility name and zip code.

Our practice regularly has around 175 patients on hemodialysis who live within five miles of the proposed facility. We anticipate that 5 to 10% of our existing hemodialysis patients will no longer require dialysis within one year due to a change in their health status. We have a large chronic kidney disease clinic, and many of the patients in the clinic will later develop end-stage renal disease.

Based on the review of our 637 Pre-ESRD patients who currently have chronic kidney disease (CKD) Stage 3, 4, or 5, we estimate that approximately 61 of them who live within five miles of the proposed facility will develop end stage renal disease within two years. We anticipate that we will refer them to the proposed U.S. Renal Care West Chicago for dialysis in the two years following project completion, as shown in *Table C*. While we


base these estimates on the zip code of the patient's residence, we will continue to respect a patient's choice of his or her dialysis provider.

We respectfully ask the Board to approve the U.S. Renal Care West Chicago, LLC CON application so that it can provide in center hemodialysis services for a growing ESRD population in the area. Thank you for your consideration.

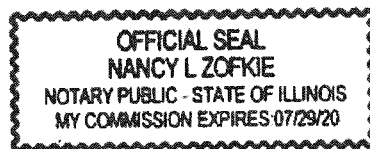
