This report summarizes the status of the above-mentioned project located at 721 E. Court Street, Suite B, Paris.

## **Status of the Project**

This project is for the establishment of an 8-station ESRD facility at Paris Community Hospital. A permit alteration was granted increasing the GSF from 5,000 to 5,245 with a cost increase from \$2,603,250 to \$2,707,415.

On October 31, 2018 a permit renewal was granted with a new completion date of March 31, 2020. The financial commitment period was also extended at that time to September 30, 2019. The project was obligated with the execution of the lease on September 30, 2019.

On February 25, 2020 a second permit renewal was granted with a new completion date of March 31, 2021. There have been no changes in the 3 weeks since the renewal was granted.

#### **Application and Certificate for Payment (AIA G702)**

There are no modernization costs so far.

#### **Anticipated Completion Date**

The project is approximately 50% complete and is expected to be complete prior to March 31, 2021.
