Dear Ms. Avery:

We received the attached letter indicating the Ferrell Hospital may be eligible for nomination to the National Register of Historic Places because of its "vital role in the community". The letter also indicates demolition of the Hospital, as proposed in our Project, constitutes an "adverse effect" which requires mitigation. We believe the adverse determination is related to the 1928 Hospital structure located at 1201 Pine Street and are seeking clarification.

Additionally, we are in the process of engaging the appropriate professionals to assist us in mitigating this adverse effect determination by the Historic Preservation Agency. It is our understanding it might take several months, or even years, to resolve this issue.

Our Hospital modernization project is critical to the communities we serve. Any Hospital facility demolition is currently slated for later project phases which will be several years away, post-project approval.

We respectfully request our Permit Application review proceed in a timely manner, and attest, via this letter, that we will diligently pursue mitigation of the Illinois Historical Preservation Agency adverse effect determination. Additionally, we attest that no Ferrell Hospital building structures will be demolished until mitigation occurs.

We expect, assuming our Permit Application is approved, the Review Board determination will be conditioned on resolving the Illinois Historic Preservation Agency adverse determination. In this context, we also assure the Illinois Health Facility and Services Review Board that it will be kept informed of our progress in this situation.

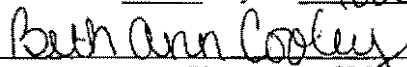

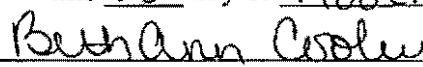

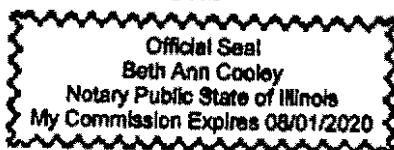

Thank you for requesting comments from our office concerning the possible effects of your project on cultural resources. Our comments are required by Section 4, Paragraph 133c21 of the Illinois State Agency Historic Resources Preservation Act (20 ILCS 3420).

We have determined that Ferrell Hospital is eligible for nomination to the National Register of Historic Places under Criterion A because of the hospital's vital role in the community. The demolition of this property constitutes an adverse effect as defined in the aforementioned Act.

At this time you should work with this agency to develop a plan to mitigate this adverse effect. Please note that no demolition should take place prior to the resolution of the disposition of this historic property. We would like to conduct a site visit at your earliest convenience so that we may see the facility and discuss the next steps with you in person.
