I understand that Ann & Robert H. Lurie Children's Hospital of Chicago has submitted a Certificate of Need application to expand the number of neonatal and pediatric intensive care beds at its main hospital location. I strongly support this application and request that this letter of support be included in the public record.

As Alderman of the 2nd Ward, which includes Lurie Children's, I think it is essential that children from across the State of Illinois and surrounding region have access to the unique intensive care services that the hospital provides. Due to capacity constraints, the hospital had to deny more than 100 requests for transfer last year, and this is not acceptable. I have reviewed the bed expansion plans with senior leaders at the hospital, and I believe the plans are thoughtful and responsible.

Lurie Children's has been located in our neighborhood since 2012. The hospital and its staff have proven themselves to be respectful and engaged members of our community.

To ensure that Lurie Children's can continue to serve all of Illinois' children who need its specialized care, I fully support their application for a Certificate of Need and urge the Board to approve it.
