Narrative Description

The Fresenius Medical Care Plainfield North facility is a certified entity that just began treating patients. It is owned by Dialysis Centers of America – Illinois, Inc. which is a subsidiary of Fresenius Medical Care Holdings, Inc. The assets of the facility, which at this point consist of the Medicare provider number and the capital contributed to the build-out of the facility and equipment, will be transferred to Fresenius Medical Care Plainfield North, LLC. Fresenius Medical Care Ventures, LLC (also a subsidiary of Fresenius Holdings) will own a 51 % interest in the Plainfield North, LLC, while Nephron Ventures, LLC will own a 25% interest and Dialysis Clinic of Plainfield, LLC will own a 24% interest. These latter two entities are physician owned. The physicians are contributing capital to the entity consistent with their ownership interest in the facility changing ownership.

The members in the facility joint venture are contributing capital to the joint venture to acquire an ownership interest in it and this is reflected in the joint venture operating agreement.

However, 2014 Financial Statements for Fresenius Medical Care Holdings, Inc. were submitted previously to the Board with #15-022, Fresenius Medical Care Blue Island. 2015 Financial Statements for Fresenius Medical Care Holdings, Inc. were submitted previously to the Board with #16-023, Fresenius Kidney Care East Aurora.
