Dear Ms. Avery,

We are writing this letter in support of the Certificate of Need application for a 100-bed behavioral hospital in New Lenox, IL through the joint venture between Silver Cross Hospital and US Health Vest.

Currently two (2) physicians, Dr Fred Moss, MD Psychiatrist (adult and child), and Dr Richard Bongard (child only, MD Psychiatrist, and one (1) mental health professional, Krista Raaties, LCSW are employed by Aunt Martha's and serve patient in the city of Joliet in Will County and throughout our service area. These providers have patients who have experienced delays in accessing inpatient psychiatric care mainly due to bed shortages. There have been many times patients have had to wait to access care leading to poor outcomes in their mental healthcare. Based on our 2015 behavioral health patient volume, Aunt Martha's primary care and mental health providers in the south suburban area refer between 60-80 children and adolescents for assessments and/or hospitalizations annually. Accordingly, we anticipate our providers would refer 160-180 patients to the proposed facility within a 24 month period after the hospital is own and accepting patients. These patients will come from the following zip codes: 60411, 60417, 60443, 60468, 60417, 60451, 60436, 60435, and 60404.

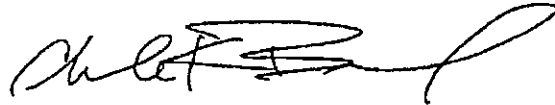
The information we have including above has not been used to support another pending or approved CON application for a behavioral hospital.

We urge you to support the approval of certificate of need application for Silver Oaks Hospital. Approval of the application will increase access to these important services in our area.

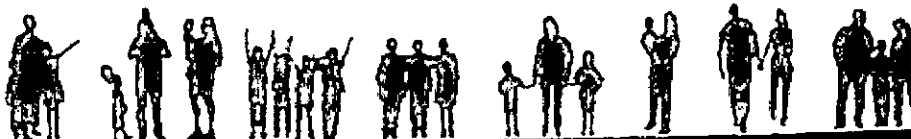

I am writing this letter in support of the Certificate of Need application for a 100-bed behavioral hospital in New Lenox, IL through the joint venture between Silver Cross Hospital and US HealthVest.

As a psychiatrist at Crossroads Counseling Services, LLC located in Morris/Grundy County and Plainfield/Will County, my patients have experienced frequent delays in accessing inpatient psychiatric care mainly due to bed shortages. There have been many times patients have had to wait to access care leading to poor outcomes in their mental healthcare.

In the past 12 months, I typically hospitalize once monthly. I would estimate a minimal of 30 referrals within a 24 month period to the Silver Oaks Hospital once the facility is open and accepting patients. These patients are coming from the following areas (New Lenox-60451, Joliet-60431, 60432, 60433, 60434, 60435, 60436, Shorewood-60404, Minooka-60447, Channahon-60410, Lemont-60439, Bolingbrook-60440, Romeoville-60446, and Mokena-60448).

The information I have included has not been used to support another pending or approved CON application for a behavioral hospital.

I urge you to support the approval of certificate of need application for Silver Oaks Hospital. Approval of the application will increase access to these important services in our area.

On behalf of the Wilmington Coalition for a Healthy Community (WCHC), a community coalition located in Wilmington, Illinois, I am writing this letter in support of the Certificate of Need application for a 100-bed behavioral hospital in New Lenox, IL through the joint venture between Silver Cross Hospital and US HealthVest.

As a community organization located in Southern Will County where there are very few behavioral health services available, the WCHC urges the approval of this application. The Wilmington Coalition in partnership with AMT Counseling, will project to refer approximately 20 people per month to Silver Oaks Hospital, when the facility is open in 2019. These patients would reside in and come from the following areas: Wilmington (60481), Diamond/Coal City (60416), Braidwood (60408), Gardner (60424), Morris (60450), Dwight (60420), Peotone (60468), Elwood (60421) and Bourbonnais (60914).

Our coalition works collaboratively with healthcare providers, as well as law enforcement and other first responders, and so we are acutely aware of the shortage of inpatient behavioral health services in Will County. This greatly affects our residents who need inpatient services, leading to long travel times and much greater difficulties in staying engaged in the care they need to resume lives as healthier and more productive individuals.

The Wilmington Coalition does not employ or contract with an MD/DO. AMT Counseling does not employ or contract with an MD/DD or clinical psychologist. AMT Counseling does accept Managed Care and has licensed clinical social workers and licensed professional clinical counselors on staff. For those reasons, this letter cannot include a signature from a physician, so we are including the signature of a licensed staff from AMT Counseling.

Thank you for considering this support letter. The information I have included has not been used to support another pending or approved CON application for a behavioral hospital.

I urge you to support the approval of certificate of need application for Silver Oaks Hospital. Approval of the application will increase access to these important services in our area.
