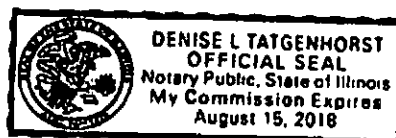

I am writing this letter in support of the Certificate of Need application for a 100-bed behavioral hospital in New Lenox, Illinois through the joint venture between Silver Cross Hospital and US Health Vest.

As a community-based organization serving children and adults with disabilities and their families, Easterseals Joliet Region, with headquarters in Will County, has and continues to have great difficulty in accessing behavioral health services critical to the individuals that we serve. There is a lack of providers, limited access to inpatient care, and limited access for those with Illinois Medicaid as their primary source of payment. These challenges have disproportionately affected some of the most vulnerable people whose health deteriorates due to lack of access and consistency in behavioral health services.

On an annual basis, Easterseals Joliet Region, on behalf of our clients, seek in-patient and out-patient behavioral health services for more than 200 children and adults with disabilities. The primary zip codes for these individuals are: Bolingbrook, Channahon, Crest Hill, Joliet, Lockport, Minooka, Naperville, Plainfield, and Shorewood.

Easterseals Joliet Region provides life span services to include Early Intervention, Outpatient physical, occupational and speech therapy, Autism services, Foster-adoptive care, Community residential homes, Social work, Child care, Caregiver education and support and other services to more than 3,200 individuals on an annual basis in a 6 county region.

The information I have included has not been used to support another pending or approved CON application for a behavioral hospital.

I urge you to support the approval of the certificate of need application for Silver Oaks Hospital. Approval of the application will increase access to these important services in our area.
