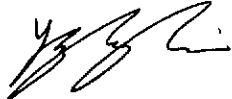

I am writing to express support of the Certificate of Need requests filed by DaVita Inc. and DuPage Medical Group, Ltd. for the development of new In-Center Hemodialysis facilities to provide life-sustaining dialysis treatment, education, and support for patients with kidney disease.

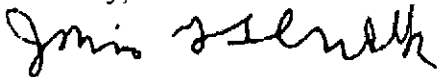
I am a diabetic patient who ended up on dialysis two and a half years ago. I have many frustrations with my current dialysis partner Fresenius Medical Care. I have had four (4) hospitalizations directly attributed to my dialysis care. I once passed out during a dialysis treatment and was bleeding from my access site. The nurse and lab technician woke me up, stopped my bleeding, and sent me home in a cab. When I arrived home five minutes later, I collapsed on the front lawn. My daughter-in-law called an ambulance and I required two pints of blood at the hospital.

Another time, I was at dialysis when it took the staff 18 tried over 30 minutes to read my blood pressure. By the time an accurate reading was obtained my blood pressure was at 217. I found out later that the Fresenius nurse had called DuPage Medical Group and increased my blood pressure medication without my knowledge or my knowledge or that of the doctors on her staff.

In contrast to my dialysis service, my patient care for all my other needs is through DuPage Medical Group. With integrated care records and coordination of services across medical specialties, DuPage Medical Group does an excellent job of coordinating my care and arranging for my treatments on a regular basis. Dr. Krouse, my primary care physician, does an excellent job managing my kidney disease, diabetes, and health complications.

Currently, there are over ten (10) Fresenius dialysis facilities within 10 miles of my home. The closest DaVita dialysis facility is 17 miles north of my home. The proposed projects would provide me, and other area patients, with more choice in dialysis care. For these reasons, I ask that the Illinois Health Facilities & Services Review Board approve the dialysis facility applications submitted by DuPage Medical Group and DaVita.

Dear Chair Olson and Members of the Illinois Health Facilities & Services Review Board:

I am writing to express my support of the DuPage Medical Group and DaVita certificate of need requests.

I am in the unique position of having been exposed to DuPage Medical Group (DMG) both as a practicing nephrologist and life-long patient. In fact, I am currently on staff in the hospital in which I was born. Growing up my pediatrician was a DMG physician and at present, both my parents are cared for by DMG physicians. The patient-physician centered model of the organization has kept my family loyal to the DMG healthcare system over the years. Now, as a practicing physician within the group I can attest with confidence that DMG's patient focus and superior integration of services results in excellent care delivered to patients at a lower cost.

As a nephrologist I take care of the sickest, most complicated subset of patients within medicine. Those with end stage renal disease (ESRD) and require time consuming, costly hemodialysis treatments. These patients have many comorbidities (diabetes, high blood pressure, heart failure) which have led their kidneys to fail and require intensive monitoring by physicians from various specialties. DMG has found a way to bridge this gap by employing physicians from all specialties and providing its service population superior and timely access to all physicians, incorporating a singular electronic medical record allowing for the highest level of coordination of care. With this said, the ESRD population at present has been left behind.

Prior to less than one year ago, there was no patient choice when it came to seeking nephrology services in the western suburbs of Chicago. There was only one group (Nephrology Associates of Northern Illinois) and thus, one choice. DMG recognized this, hired multiple nephrologists with myself included, and we are now seamlessly working together to provide coordinated care. Similarly, at present when it comes to dialysis services in the western suburbs there is no patient choice. It has been monopolized by one large organization who is in partnership with the aforementioned group. As a physician and patient advocate, I challenge the board to allow our patients a choice in this highly populated service area.

For decades now, DMG has been a proven healthcare leader with sustained focus on innovation. A prime example being the breakthrough center – a DMG concept now recognized nationally by organizations such as Blue Cross Blue Shield – where the sickest of patients are chosen and

taken care of in a multi-disciplinary fashion which simultaneously reduces hospitalizations and costs from duplicative and delayed treatments. With the integration of dialysis units into the DMG model, the potential of new innovation for our patients is very exciting.

I am confident that DMG will continue its track record of patient focused care, integration of care amongst all physicians, and innovation to provide superior care delivered at a lower cost. In partnership with DaVita, this will allow our patients a choice and a voice that can be heard.

For these reasons, I hope DuPage Medical Group and DaVita are afforded an opportunity to provide dialysis care within my community.
