In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish an End Stage Renal Dialysis (ESRD) facility in an existing acute care hospital, in Chicago. Project #17-017, Provident Hospital of Cook County, Chicago. Applicants: Provident Hospital of Cook County, Cook County Health & Hospitals System. The applicants propose to establish a 12-station ESRD facility, in 6,550 GSF of modernized space, located in Provident Hospital of Cook County, 500 East 51st Street, Chicago. Project cost: \$2,438,825.

The application contained a Safety Net Impact Statement and was declared complete on April 25, 2017.
