


The Winnebago County Health Department is the Illinois state certified local health department for Winnebago County responsible for the health of approximately 300,000 residents, the majority of which reside in the City of Rockford. The most current community health assessment conducted by WCHD identified three (3) health priorities: Maternal and Child Health; Mental/Behavioral Health; and Violence Prevention with a focus on health equity and access to care. The applications being submitted by SwedishAmerican Hospital directly and indirectly addresses these health priorities.

The establishment of a state-of-the art Women and Children's Center will expand access to maternal and infant care accessible to community areas and populations that have historically been underserved and at the highest risk for poor outcomes including pre-term and low birthweight infants. The availability of a Neo-Natal Intensive Care Unit will further support family engagement with infants who need specialized care demonstrating their commitment to family infrastructure.

SwedishAmerican is the largest birthing center in Rockford and has achieved both the Healthgrades' Labor and Delivery Excellence Award and designation as *Baby-Friendly* from the World Health Organization demonstrating their ability to deliver high quality care to both mother and infant.


