The RAEDC works closely with many partners to serve as a one-stop resource for clients, to improve the competitiveness of the region and to engage the community in the daily work of economic development.

SwedishAmerican has a long rich tradition of not only providing exceptional regional health care, but also doing such in distressed areas of the city. Most recently SwedishAmerican announced the expansion of medical services in these areas, in addition to the over \$500 million already invested into the main campus. However, SwedishAmerican's investments have expanded beyond health care. Through its foundation, SwedishAmerican has invested in housing for its families and employees from the neighborhoods surrounding their main campus. SwedishAmerican is a true community partner.

The RAEDC supports the SwedishAmerican project in which they continue to invest in our region and create quality primary jobs. Dear Chairwoman Olson,


The Rockford Area Convention & Visitors Bureau is in strong support of the SwedishAmerican expansion and modernization projects and urges approval of the CON and COE applications before your Board.

SwedishAmerican has been an important part of our community serving at its original downtown hospital campus for more than a century and this project will bring needed healthcare and economic benefits to our city and region.

I attended the news conference announcing this project and know its involves a \$130 million expansion and modernization that will include private in-patient rooms, upgraded emergency department, and renovated operating rooms and cath labs. Importantly, it includes 10 additional behavioral health beds and establishes a neo-natal intensive care unit. This will allow SwedishAmerican to apply for designation as a Level III nursery which increases access and care for its patients in this part of the community.
