Dear Ms. Olson:

I am writing on behalf of Fresenius Kidney Care to inform the Board that in DaVita's application for the Edgemont facility being heard November 14, 2017, DaVita presented Dr. Cheema's physician support letter from #16-037, DaVita Foxpoint Dialysis, Granite City (approved March 2017), as evidence that the Foxpoint facility will be at 80% utilization two years after beginning operations, thereby one of the reasons the Edgemont facility is needed. DaVita presented this letter knowing that it is irrelevant since Dr. Cheema was no longer associated with the Foxpoint project as of February 2017, even prior to its approval. Dr. Cheema confirmed he is no longer supporting the Foxpoint facility with his patients per his letter to the Board dated October 18, 2017 (see attached).
