Dear Ms. Olson:

I am writing to voice my full support for DaVita Romeoville Dialysis. This clinic will address the need for services for people with kidney failure who live in northern Will County. The Romeoville area of Will County has high population density and is growing. For my part, it provides a comfortable lifestyle for seniors. As a health care provider, I understand how the growing demand for dialysis services across the state is being driven by aging. Like other organs, kidney function declines with age. As we see a growing senior population cohort due to the baby boomers, high-quality innovative providers like DaVita need to provide an adequate supply of clinics which are close to patients home and with available treatment slots.

Beyond aging, lifestyle issues with overconsumption of packaged products and other convenient, high calorie, nutrient sparse foods and a sedentary lifestyle contribute to the disease burden this country faces with renal failure. Being overweight is a main risk factor for both of the underlying causes of kidney failure, diabetes and hypertension.

There is no overutilization of dialysis services. You are either in kidney failure and you need the services or your kidneys function. Further, the reimbursement is based on treatments, not buildings. So the risk of overbuilding lies only with the provider, This agency must error on the side of access - overall supply must be available and these clinics must be placed in areas where patients live.

I urge you to approve Romeoville Dialysis.

I write to express my support for a project that the Illinois Health Facilities and Services Review Board will hear at the upcoming June meeting: Romeoville Dialysis Clinic.

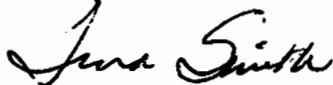

I write to share my full support for DaVita's proposed Romeoville Dialysis clinic. I live in Carillon Lakes, an active retirement community in northern Will County. The proposed clinic would be a welcome addition to help improve dialysis access for those in my community.

The Romeoville area of Will County is densely populated, more so than other parts of the planning area, and continues to grow. Like many others in the area, my wife and I enjoy the area's comfortable lifestyle for seniors. Based on our professional experiences, we also know first-hand how the aging population is driving growing demand for health care services including dialysis in Illinois. Kidney function tends to decline with age and it is also driven by other chronic diseases that have higher prevalence in the elder generations. As our baby boomer generation continues to grow the senior population, we will need innovative health care providers, like DaVita, to address these issues and ensure that we have appropriate access to the services we need. The proposed Romeoville clinic will help ensure ongoing access for dialysis services in the community that are high-quality, convenient for area residents, and have improved availability compared to current providers that are nearing capacity.

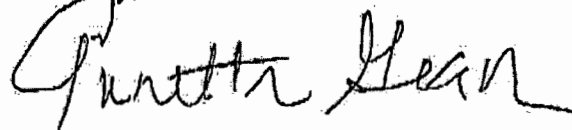
