I write in support of Smith Crossing's addition of a new short-term stay rehabilitation center on its campus in Orland Park, Illinois. Smith Crossing currently has 16 beds dedicated to short-term stay rehabilitation patients. It now seeks to build a second "state-of-the-art" wing with an additional 46 rehabilitation beds, increasing its capacity to 62 rehabilitation beds. As part of this expansion, Smith Crossing will be able to serve individuals who are medically challenged with cognitive limitations.

With only 16 rehabilitation beds, Smith Crossing can only accommodate 11 percent of the requests and referrals it receives from hospital care coordinators and other senior living communities.
