Deerpath Ambulatory Surgical Center, LLC in Morris, Illinois, is submitting this progress report for permit #17-059. This project was approved by the Board on January 9, 2018 and has a completion date of September 30, 2019.


The following indicates the project's current status:

1. To date the following surgical specialties have been added to the ASTC: Endoscopy; ENT; and Ophthalmology.
2. The ASTC is on track to add one new specialty in each two to three-month period and plan for all four additional specialties (Urology, GYN, General Surgery, and Pain Management) to be successfully launched by September 30, 2019.
3. The Project Scope is consistent with the approved CON permit. The required project costs remain in line and have not exceeded the approved permit amounts. To date, the ASTC has spent \$495,104.
4. The source of the funds remains same as the original permit. It is anticipated that the project will not exceed the Total Project Cost approved in the original permit (Attachment 1).

It is anticipated that the project will be completed by September 30, 2019 and that the project cost will remain within the funds approved by the Board.
