Dear Chairwoman Olson:

On behalf of the Rockford Ministers' Fellowship ("RMF"), an organization comprised of Rockford-area clergy who primarily serve its African-American community, I write to express enthusiastic support for the above-referenced project. Your approval of the SwedishAmerican hospital CON and COE applications will help meet the healthcare needs of our congregants. Your favorable action will help more equitably distribute health care resources in our region, and bring proximate access to the highest level of care to the west and south side areas of Rockford. We are all God's children, with equal entitlement to healthcare access and the highest level of quality care.

As the applications reflect, the proposed \$130 million modernization and expansion will include private inpatient rooms, as well as a modernized Emergency Department, operating rooms, and other needed services – in the federally designated "health professional shortage area" of Rockford. The need is clear.

Most critically, SwedishAmerican plans to establish a state-of-the-art Women's and Children's Center that will include a Neo-natal Intensive Care Unit (NICU). Once approved, the NICU would allow SwedishAmerican to apply for designation as a Level III Nursery and treat more complex neo-natal patients. SwedishAmerican is already the largest birthing center in Rockford, and is the only area hospital to have received

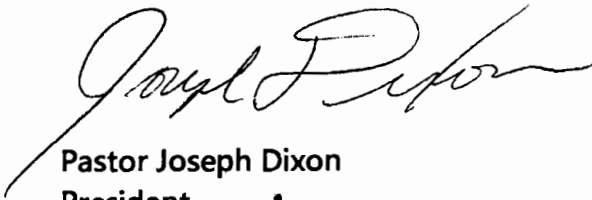

the Healthgrades' Labor and Delivery Excellence Award. The addition of a Level III Nursery at SwedishAmerican, together with the new Women's and Children's Center, will assure access to the highest quality of care for all Rockford area families.
