Dear Mr. Roate:

This letter responds to your requests for additional information regarding the completeness review for Project #18-027, Aghapy Surgical Center. The attached documents include the following:

1. A copy of Dr. George N. Atia's Illinois medical license.
2. Revised Attachments 38 and 39 providing estimates of charity care, reduced charges and fee waivers associated with Dr. Atia's existing medical practice and the minimum amount of anticipated annual charity care, reduced charges and fee waivers expected for the proposed ASTC.
3. The space lease for the building in which Dr. Atia currently conducts his medical practice at 200 Fox Glen Court, Barrington, Illinois.

Also, following up on our telephone conversation on August 22nd, the proposed ASTC will be located in an existing building that is owned by an entity managed by Dr. Atia's wife, Ms. Emily Atia, which owns the building and leases it to Dr. Atia's medical practice. The building was completed in 2007 and Dr. Atia has been practicing at that location since 2007. As the space lease is associated with Dr. Atia's existing practice and is not a cost associated with establishing the proposed ASTC, it was not included in the project costs for the ASTC. Also, as Dr. Atia's medical practice acquired its interest in the building over 10 years ago, it was not an "acquisition that has occurred within two years prior to the date of application for permit submission [which] must be included as part of project costs" under Section 1120.110 of the Review Board's rules. The medical equipment and fixtures are also leased by the same entity managed by Ms. Emily Atia to Dr. Atia's existing medical practice, and were excluded from the project costs for the same reasons.

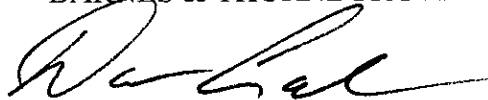

Safety Net Impact Statement

The proposed ASTC will not have an adverse impact on essential safety net services in the community. The project will provide outpatient gastroenterology services to Medicaid patients that are not currently available in the community. To the applicants' knowledge, the project will not adversely impact the ability of another provider or health care system to cross-subsidize safety net services.

The applicants do not currently own or operate any health care facilities and, therefore, there are no methodologies specified by the Review Board for reporting historical amounts of charity care or Medicaid information. In addition, the applicant Aghapy Surgical Center, S.C., is a newly formed entity for purposes of this project.

The applicant George N. Atia, M.D., S.C. estimates that his current medical practice performs between 10 to 15 cases a year with no charge, representing approximately \$20,000 in charity care. In addition, the practice reduces charges from 40% to 60% for primarily self-pay patients which represents another \$20,000 annually. The practice also reduces charges or waive the fees if patients cannot pay in amounts totaling about \$60,000 a year.

The applicants anticipate that charity care and reduced fees at the proposed ASTC would consist, on an annual basis of: (a) at least \$10,000 in cases for which no charge is made; (b) at least \$10,000 in reduced charges primarily for self-pay patients, and; (c) at least \$30,000 in reduced charges or waived fees where patients are unable to pay.

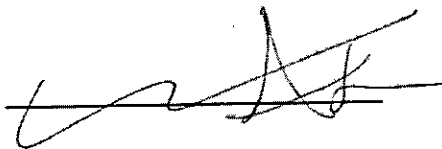
