I am the Administrative Assistant at the Blessing Foundation in Quincy, Illinois. I would like to express my opposition to Quincy Medical Group's Certificate of Need project (#18-042).

Blessing Hospital and Quincy Medical Group have worked together successfully to provide key health services to our community, and our community deserves a continuation of their cooperation among the facilities. The separation of the existing surgical center is not necessary in volume nor accessibility opportunities, as it is a duplication and would pull apart essential safeties to our community including:

- large numbers of existing Blessing Health System jobs;
- the revenue that would leave the Quincy area due to Quincy Medical Group's business partner (Unity Point is 40% owner) being an Iowa-based organization; and
- a large negative financial impact to Blessing's community benefit programs and safety net services (which include inpatient behavioral medicine and trauma care, and the financial support to the education of Bless-Rieman College of Nursing and SIU Family Medicine Residency Program). This area desperately needs both, and Blessing Hospital has impressively and continually stepped up and done the right thing for the community in its consideration of projects and processes to fulfill the needs of Quincy and the surrounding area. This is the kind of projection and consideration our community desires and deserves.

I respectfully ask that the Health Facilities and Services Review Board deny CON application 18-042 for a potentially duplicated outpatient surgery center. Thank you for your consideration.

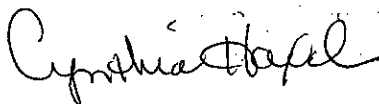
Dear Ms. Avery:

I am an employee of Denman Services, Inc. which is owned by Blessing Health System and a residence of Quincy Illinois. I oppose the Quincy Medical Group's proposal.

The Quincy Medical Group proposal is a duplication of an outpatient surgery center that is owned by Blessing and managed by the Quincy Medical Group in Quincy. I have concerns with UnityPoint, Quincy Medical Group's Des Moines, Iowa business partner being a 40 percent owner of the proposed surgery center and a portion of the profits leaving the Quincy area. I believe this proposal would damage our community benefit programs and services. Much of the revenue Blessing generates from outpatient surgery is used to fulfil its not-for-profit mission of providing Safety Net services to our region such as behavioral health care and trauma care. Blessing is the only health care provider in the region who offers these critical services. It is important to our community these services stay in place. As a non-profit healthcare provider, Blessing provides financial support to the education of healthcare professionals such as Blessing-Rieman College of Nursing & Health Sciences and the SIU Family Medicine Residency Program and charity care to those in need of healthcare, regardless of their ability to pay. The loss of outpatient surgery revenue will threaten these and other community benefit programs, not to mention the loss of approximately 400 jobs. It is in our communities' best interest for Blessing and the Quincy Medical Group to work together to delivery key services. They have been successful with the current outpatient surgery center and the Cancer Center. I personally have help to raise funds for the Cancer Center. It would benefit the community if Blessing and the Quincy Medical Group would continue to work together delivering key health services to the community and find new ways to meet community needs.

Dear Ms. Avery:

I have worked for Blessing Health System for 32 years. In my prior responsibilities and in my current role as Executive Vice President/Chief Strategy Officer, I have witnessed our volunteer Board of Trustees' consistent financial stewardship and commitment to serve all individuals in our region, regardless of their ability to pay. The ability of the health system to do this requires a constant balance between those services that provide a margin and those much-needed critical resources that require ongoing subsidy. One huge example is that of mental health services. Blessing Health System has always recognized the importance of these services and has remained committed as supported by our comprehensive mental health service offerings, as others have exited the business in our region. As a long term Blessing Health System team member, I was able to see firsthand the reduction in the cost of care when Blessing and the former St. Mary Hospital merged services. Today, Blessing Health System is able to provide over six million dollars in charity care per year and approximately 63 million in total community benefits on an annual basis.

Quincy Medical Group has previously been in an ownership position of an ASTC and due to financial pressures was forced to sell the service to Blessing Health System in 2006. At that time, we paid approximately \$13,000,000 for the center and simultaneously entered into an arrangement whereby Quincy Medical Group provides management services through a market-based contract to operate the center, which still exists to this day. Because Quincy Medical Group is responsible for effectively managing the service, we were quite surprised as to the reasoning within the CON, which seems to suggest a self-described breach of duty as manager of the center. As mentioned previously, Quincy Medical Group's financial position was instrumental in the selling the first time around and when reviewing their recent financial information outlined within the CON, it is apparent that their financial risk is high and the further burden of debt and leverage could result in failure. Failure could result in personal physician risk, physicians leaving the community and/or selling out to an out of town entity therefore taking money out of the community forever, which would further erode the community's safety net services. (As would the approval of the CON as 40% will go out of the community to Unity Point based in Des Moines, Iowa.)

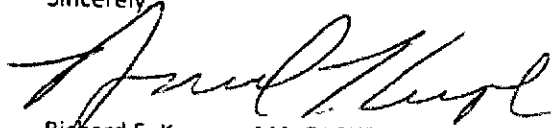
Finally, Quincy Medical Group has a historical track record of "cherry picking" payers, thus leaving the health system with a less than adequate reimbursement mix. Approval of this CON would compound this issue.

We look forward to the community hearing on January 24, 2019 and the CON hearing on March 5, 2019 at which time I believe you will come to understand the many inaccuracies Quincy Medical Group has documented for the record within their filing.

I respectfully ask the Health Facilities and Services Review Board to deny CON Application 18-042/Quincy Medical Group Surgery Center.

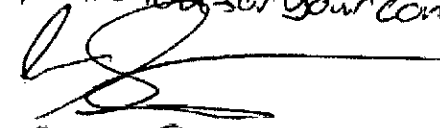

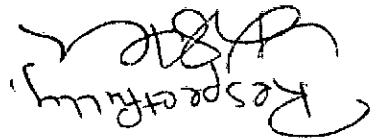
